#### RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of March 5, 2021 (the "Effective Date") by FIRST EAGLE ALTERNATIVE CREDIT, LLC (f/k/a NEWSTAR FINANCIAL, INC.) (the "Administrative Agent"), in favor of U.S. NURSING CORPORATION and FASTAFF, LLC ("Grantors"). WHEREAS, Grantors have satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral, and (iii) re-assigns to Grantors, any right, title or interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby. Each Grantor or its representative authorized agent is authorized to record this Release with the USPTO and any other jurisdiction in which the Trademark Security Agreement or the Administrative Agent's security interest in any Trademark Collateral was filed, recorded or registered.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
