Release of Security Interests in Intellectual Property

This Release of Security Interests in Intellectual Property (the "Release") is made as of March 6, 2018 by BANK OF MONTREAL, as administrative agent for the Lenders (in such capacity, the "Administrative Agent") in favor of IEWC CORP., a Wisconsin Corporation ("IEWC"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below) or the IP Security Agreement (as defined below), as applicable.

WHEREAS, IEWC, the other Debtors party thereto and Administrative Agent are parties to that certain Security Agreement (the "Security Agreement") dated as of January 8, 2016, and to that certain Confirmatory Assignment of Security Interests in United States Patents, Trademarks, and Copyrights (the "IP Security Agreement") dated as of January 8, 2016, whereby IEWC granted to Administrative Agent a continuing security interest in all of IEWC's right, title and interest in and to (1) Patents, Trademarks (and the goodwill of the business in connection therewith), and Copyrights, including those set forth in Schedule A attached hereto (as defined in the IP Security Agreement), (2) all proceeds and products of the Patents, Trademarks, and Copyrights, and (3) all causes of action arising prior to or after the date hereof for infringement of any of the Patents, Trademarks, or Copyrights, or unfair competition regarding the same (collectively referred to herein as the "IP Collateral"), as security for the Obligations owing by IEWC to Administrative Agent and the Lenders;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on January 14, 2016 at Reel 5709, Frame 0455;

WHEREAS, IEWC has requested that Administrative Agent, and Administrative Agent now desires to, terminate and release its continuing security interest in and lien on the IP Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby automatically and unconditionally releases and terminates its continuing security interest in and lien on all of IEWC's right, title and interest in and to the IP Collateral, including:

(i) all of IEWC's right, title and interest in and to the Patents, Trademarks, and Copyrights set forth in Schedule A, now owned or from time to time after the date hereof owned or acquired by IEWC;

(ii) all proceeds and products of the Patents, Trademarks, and Copyrights;

(iii) the goodwill of the business with which the Trademarks are associated;

and

(iv) all causes of action arising prior to or after the date hereof for infringement of any of the Patents, Trademarks, or Copyrights, or unfair competition regarding the same.

2. Administrative Agent hereby terminates the IP Security Agreement and fully and finally terminates, discharges, releases, cancels, reassigns, grants and conveys to IEWC, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in and to the IP Collateral.

3. Administrative Agent hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.

4. This Release shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.
