NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency, and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment. Assignors do hereby assign, transfer, convey and deliver unto Assignee all of their right, title and interest, throughout the world, in and to the Trademarks (including any common law rights that may exist and are associated therewith), together with: (i) all registrations and applications for registration of the Trademarks, including without limitation those identified on the attached Exhibit A; (ii) the goodwill of the business symbolized by and associated with the Trademarks, the same to be held and enjoyed by Assignee, its successors, and assigns; and (iii) all rights to all past, present, and future claims for infringement or dilution of, or damage or injury to, the Trademarks, including without limitation the right to grant licenses, to bring lawsuits or administrative actions, and to recover damages and profits for any past, present, and future infringement, whether known or unknown, now existing or hereafter arising. Assignors consent to the recordation of this Assignment with any governmental agency. Assignors acknowledge that subsequent to the date hereof, Assignors shall not claim to possess any right, title or interest in and to such Trademarks.
2. Further Assurances. Assignors agree to provide reasonable assistance to Assignee, at Assignee's cost, to evidence in every legal way, record and perfect this Assignment and to apply for and obtain recordation of it.
