## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “Assignment”) effective as of December 17, 2020 is made and entered into by and between Bensussen, Deutsch & Associates, LLC, a Washington limited liability company (“Assignor”), in favor of ACCO Brands Corporation, a Delaware corporation, as assignee (“Assignee”). Capitalized terms that are not defined herein shall have the meaning ascribed to them in the Purchase Agreement (as defined below).

WHEREAS, Assignor, ACCO Brands USA LLC (“Buyer”), Assignee, Bensussen Deutsch Holdings, Inc., Jacob B. Deutsch and Eric E. Bensussen are parties to that certain Equity Purchase Agreement, dated November 10, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Purchase Agreement”), pursuant to which Assignor agreed to effectuate the sale of the Business to Buyer through the transfer of all issued and outstanding Company Units and the assignment of the Directly Transferred Assets, including all trademarks, service marks, certification marks, collective marks, and trade dress, and all applications and registrations for the foregoing, in each case that are owned by the Assignor and its Subsidiaries and Related to the Business, including without limitation those applications and registrations identified in the attached Schedule A, and all renewals of same, in each case, as of immediately prior to the Closing (collectively, the “Trademarks”), to Buyer (or any designated Subsidiary of Assignee); and

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to execute this Assignment in order to effectuate, evidence and record the assignment of the Trademarks from Assignor to Assignee in the United States Patent and Trademark Office and any other applicable intellectual property offices.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Conveyance and Acceptance. Assignor (directly or through its Subsidiaries) hereby contributes, transfers, assigns and conveys to Assignee all of Assignor’s right, title and interest in and to (i) the Trademarks, including all goodwill associated therewith and symbolized thereby, (ii) all rights to sue or otherwise recover for past, present and future infringement dilution or other violations of any of the foregoing, (iii) all rights to obtain renewals, continuations, divisions and extensions of legal protection pertaining to any of the foregoing, (iv) all rights of priority arising from any of the foregoing, and (v) all other rights corresponding to any of the foregoing throughout the world, in each case as of immediately prior to the Closing. Without limiting any representations or warranties in the Purchase Agreement, the foregoing assignment is made without representation or warranty of any kind.

2. Further Assurances. Upon request from the Assignee and at Assignor’s expense (except as set forth on Schedule A), Assignor agrees to, and agrees to cause its Subsidiaries to, execute local assignments and take such other reasonable actions with respect to the Trademarks (and any other marks included in the Directly Transferred Assets) as may be necessary or

advisable under applicable law to effectuate or perfect the assignment of such Trademarks or other marks to Assignee, to clean up any chain-of-title issues with respect to such Trademarks or other marks, and to release any security interests recorded against such Trademarks with the United States Patent and Trademark Office, other foreign trademarks offices, or other Governmental Entities in all applicable geographies, all such assignments and other documentation to be duly executed, delivered, notarized and apostilled as reasonably necessary at Assignor's expense (except as set forth on Schedule A), and to be in a form and substance reasonably satisfactory to Assignee. For the avoidance of doubt, except as set forth on Schedule A. Assignor will be responsible for paying any applicable recording fees and reasonable outside counsel filing expenses in connection with the foregoing, and in connection with recordation of this Assignment.

3. Recordation. Assignor hereby authorizes and requests the United States Patent and Trademark Office and any other applicable intellectual property office to record Assignee as the assignee and owner of the Trademarks.

4. Governing Law. This Assignment will be governed by, and construed and enforced in accordance with, the substantive laws of the State of New York, without regard to its principles of conflict of laws.


5. Counterparts. This Assignment may be executed and delivered in any number of counterparts (including by facsimile or pdf), each of which shall be deemed to be an original instrument, and all of which shall together constitute the same agreement.
