## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on March 10, 2021, by CORTLAND CAPITAL MARKET SERVICES LLC, AS AGENT, (the "Collateral Agent"), to the various owners listed on Schedule A, attached hereto and incorporated herein by this reference, (the "Grantors").

WHEREAS, the Grantors and the Collateral Agent are party to (i) that certain Credit Agreement, by and among the Collateral Agent, as administrative agent and collateral agent for the lenders party thereto, the Grantors and other parties party thereto from time to time, dated as of February 9, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and (ii) that certain Second Lien Guaranty dated as of February 9, 2017 (the "Collateral Agreement") and the Grantors, as applicable, are party to a Trademark Security Agreement dated as of February 9, 2017, a Trademark Security Agreement dated as of June 29, 2017, a Trademark Security Agreement dated as of July 12, 2018, a Trademark Security Agreement dated as of April 25, 2019 a Trademark Security Agreement dated as of November 12, 2019, a Trademark Security Agreement dated as of December 31, 2020 (collectively, the "Trademark Security Agreements"), as applicable;

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreements, the Grantors granted to the Collateral Agent, among other collateral, a continuing security interest in all of the Grantors' rights, titles and interests, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Trademark Security Agreements were recorded in the United States Patent & Trademark Office on February 22, 2017 at reel/frame 5995/0267, July 17, 2017 at reel/frame 6106/0909, May 15, 2019 at reel/frame 6645/0885 and reel/frame 6645/0833, November 14, 2019 at reel/frame 6795/0749 and December 31, 2020 at reel/frame 7153/0335

WHEREAS, the Grantors have performed all of their respective obligations under the Credit Agreement and accordingly the Collateral Agent has agreed to terminate and release their security interest in the Trademarks, and retransfer and reassign to the Grantors without recourse all of the Collateral Agent's right, title and interest in and to those Trademarks.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases any security interest it may have in the Trademarks, and reassigns any and all right, title and interest it may have in and to those Trademarks without recourse to the relevant Grantors.

FURTHERMORE, the Collateral Agent hereby authorizes the Grantors and its authorized representatives to record this Release with the United States Patent & Trademark Office and agrees to take all further actions, and provide to the Grantors, all such cooperation and assistance (including without limitation the execution and delivery of any and all documents


or other instruments) reasonably requested by the Grantors, at the Grantors' respective sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING HEREUNDER OR RELATED TO THIS RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
