RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Assignment for Security - Trademarks, dated January 16, 2018 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office (the "USPTO") at Reel 6250, Frame 0400, comScore, Inc., a Delaware corporation, Rentrak, LLC, an Oregon limited liability company, Proximic, LLC, a Delaware limited liability company, and M.Labs, LLC, a Delaware limited liability company (each, a "Releasee" and, together, the "Releasees"), granted to Starboard Value and Opportunity Master Fund Ltd. 
NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

Releasor, without representation, warranty or recourse, hereby (a) releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Collateral, including, without limitation, the trademark and service mark registrations and applications listed on Schedule A attached hereto, and (b) authorizes the recording of this Release of Security Interest in Trademarks with the USPTO at the Releasees' expense.
