SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

March 23, 2021

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, ALLIANCE APPAREL GROUP, INC., a Delaware corporation, FWRD, LLC, a California limited liability company, and EMINENT, INC., a Delaware corporation (together the “Grantors” and each a “Grantor”), hereby grant to BANK OF AMERICA, N.A., as Collateral Agent for its own benefit and the benefit of the other Secured Parties (as defined in the Security Agreement referred to below), having an office at 100 Federal Street, 9<sup>th</sup> Floor, Boston, Massachusetts 02110 (the “Grantee”), a continuing security interest in the following: (i) all of the Grantors’ rights, titles and interests in, to and under the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications set forth on Schedule A attached hereto (the foregoing, collectively, the “Marks”), (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT (this “Grant”) is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the Security Agreement by, among others, the undersigned Grantors, the other Grantors party thereto (as defined therein), and the Grantee, dated as of March 23, 2016 (as amended, modified, supplemented or restated hereafter, the “Security Agreement”).

WHEREAS, pursuant to the Security Agreement, that certain TRADEMARK SECURITY AGREEMENT, dated as of March 23, 2016, in favor of Grantee (as amended, supplemented or otherwise modified and in effect, the “Trademark Security Agreement”), was

recorded with the United States Patent and Trademark Office on March 25, 2018 at Reel 005758, Frame 0190.

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth herein and in the Security Agreement and Trademark Security Agreement, this Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Grant and the transactions contemplated hereby shall be governed by, and construed in accordance with, the law of the State of New York.
