**Termination and Release of Trademark Security Interest**

This **Termination and Release of Trademark Security Interest** (the "Trademark Release"), dated as of March 30, 2021 (the "Effective Date"), is made by **KOBRA INTERNATIONAL, LTD.**, a New York corporation (the "Grantor") and **ISRAEL DISCOUNT BANK OF NEW YORK**, as Administrative Agent (in such capacity, the "Secured Party"). The Grantor and Secured Party are sometimes referred herein as each a "Party" and, collectively, the "Parties."

WHEREAS, pursuant to the terms of that certain (i) Amended and Restated Credit Agreement dated as of June 15, 2015 (as amended and/or supplemented from time to time, the "Credit Agreement") by and among the Grantor, the lenders from time to time a party thereto (collectively the "Lenders") and the Secured Party, (ii) Grant of Security Interest (Trademarks) dated as of November 14, 2007 (the "2007 Grant"), (iii) Amended and Restated Security Agreement, dated as of June 15, 2015 (as amended and/or supplemented from time to time (the "2015 Security Agreement") by and between the Grantor, the subsidiaries of the Grantor from time to time party thereto and the Secured Party, and (iv) Grant of Security Interest (Trademarks) dated as of June 15, 2015 (the "2015 Grant") by and between Grantor and Secured Party, the Grantor has secured certain of its Obligations (as defined in the Credit Agreement) by granting to the Secured Party for the benefit of the other Lenders a continuing security interest in substantially all personal property of the Grantor, including all right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined below).

WHEREAS, the 2007 Grant was recorded with the United States Patent and Trademark ("USPTO") Office on December 13, 2007 at trademark assignment **Reel: 003679 Frame: 0021, 0022, 0023, 0024, 0025, 0026, 0027**, and the 2015 Grant was recorded with the USPTO on June 23, 2015 at trademark assignment **Reel: 005558 Frame: 0533**.

WHEREAS, the Secured Party wishes to terminate and release its lien and security interest in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Parties, Secured Party hereby represents, warrants, covenants and agrees, for the benefit of Grantor, as follows:

1. Defined Terms. Unless otherwise defined herein, capitalized terms defined in the Credit Agreement and the 2015 Security Agreement and used herein, have the meaning given to them in the Credit Agreement and the 2015 Security Agreement, as applicable.

2. Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its lien and continuing security interest in all of the Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or existing or hereafter acquired or arising:

(i) each Trademark owned by the Grantor, including, without limitation, each Trademark registration and application referred to in Schedule 1 hereto; and

(ii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Grantor against third parties for past, present or future unfair competition with, or violation of intellectual property rights in connection with or injury to, or infringement or dilution of, any Trademark owned by the Grantor (including, without limitation, any Trademark identified in Schedule 1) together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof and any and all causes of action which may exist by reason of infringement thereof.

3. Further Assurances. Secured Party hereby authorizes Grantor to (i) record this Trademark Release with the USPTO, (ii) file UCC termination statements with the applicable filing office in order to memorialize the release of the security interest of the Secured Party in the Trademark Collateral, and/or (iii) otherwise record or file this Trademark Release in the applicable foreign or domestic governmental office or agency. Secured Party hereby further agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantor's expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.

4. Counterparts. This Trademark Release may be executed in any number of counterparts and by the different Parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original, and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Release electronically or by telecopy shall be as effective as delivery of a manually executed counterpart of this Trademark Release.

5. Successors and Assigns. This Trademark Release will be binding on and shall inure to the benefit of the Parties hereto and their respective permitted successors and assigns.






