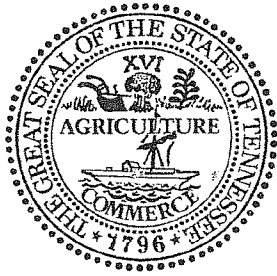


To the Secretary of State of the State of Tennessee:

Pursuant to the provisions of Section 48-60-105 of the Tennessee Nonprofit Corporation Act, as amended, the undersigned corporation adopts the following articles of amendment to its amended and restated charter:

1. The name of the corporation is Saint Thomas Health Services.
2. The corporation is not for profit.
3. The text of the amendment is as follows: Article I, Section 1.1, of the amended and restated charter of the corporation is deleted and the following language shall be substituted in its place:
  - 1.1 The name of the Corporation is Saint Thomas Health.
4. The Articles of Amendment were duly adopted by the sole Member of the Corporation.
5. The Articles of Amendment were duly adopted by the Board of Trustees of the Corporation at a meeting held on June 9, 2011.
6. Approval of the amendment to the charter by some person or persons other than the Member, the Board of Trustees, or the incorporator, is not required pursuant to Section 48-60-301 of the Tennessee Nonprofit Corporation Act, as amended.
7. The Articles of Amendment shall be effective on the date of filing.
