## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of April 15, 2021, by U.S. Bank National Association, in its capacity as collateral agent (the “Collateral Agent”) for the Secured Note Parties (as defined in the Indenture (as defined below)), in favor of MICHAELS STORES PROCUREMENT COMPANY, INC., a Delaware corporation (as successor to each of DARICE, INC., an Ohio corporation, and LAMRITE WEST, INC., an Ohio corporation), MICHAELS STORES, INC., a Delaware corporation (as successor to AARON BROTHERS, INC.), and MICHAELS STORES PROCUREMENT COMPANY, INC., a Delaware corporation (each a “Grantor” and collectively the “Grantors”). Capitalized terms used but not defined herein shall have the meaning set forth in the Trademark Security Agreements or the Indenture, as applicable.

**WHEREAS**, pursuant to (i) the Indenture, dated as of October 1, 2020 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Indenture”), by and among Michaels Stores, Inc., a Delaware corporation, as issuer, the guarantors from time to time party thereto, U.S. Bank National Association, in its capacity as trustee, and the Collateral Agent and (ii) the Notes Security Agreement, dated as of October 1, 2020 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Grantors, the other assignors from time to time party thereto and the Collateral Agent, the Collateral Agent and the Grantors entered into a Grant of Security Interest in United States Trademark, dated October 1, 2020, which was recorded with the U.S. Patent and Trademark Office on October 8, 2020 at Reel/Frame 7069/0950 (the “Trademark Security Agreement”);

**WHEREAS**, pursuant to the Indenture, the Security Agreement and the Trademark Security Agreement, each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent a continuing security interest (the “Security Interest”) in all of the Grantors’ right, title or interest in or to the Trademarks (as such term is defined in the Security Agreement) now owned or at any time hereafter acquired by the Grantors or in which the Grantors now have or at any time in the future may acquire any right, title or interest, including, without limitation, (i) those items listed on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the “Trademark Collateral”);

**WHEREAS**, pursuant to the Release Agreement, dated as of the date hereof, by and among, among others, the Collateral Agent and the Grantors, the Collateral Agent has agreed to execute and deliver this Release.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release. The Collateral Agent, on behalf of the Secured Note Parties, without recourse, representation or warranty of any kind, hereby terminates, cancels and releases the Security Interest in the Trademark Collateral, and hereby assigns and conveys to each Grantor all of its right, title and interest in, to and under the Trademark Collateral of such Grantor.
2. Recordation. The Collateral Agent authorizes each Grantor (and any person or entity hereafter having any right, title or interest in, to or under the Trademark Collateral of such Grantor) to record this Release with the U.S. Patent and Trademark Office.

3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
4. Concerning the Collateral Agent. U.S. Bank National Association is executing this Release not in its individual or corporate capacity but solely in its capacity as Collateral Agent under the Indenture. In acting hereunder, the Collateral Agent shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Collateral Agent under the Indenture, as if such rights, privileges, immunities and indemnities were set forth herein.
