TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 15, 2021 by JPMORGAN CHASE BANK, N.A. (the "Releasor") (as assignee of security interest in trademarks from DEUTSCHE BANK AG NEW YORK BRANCH, assignor of security interest in trademarks (the "Assignor")) in favor of DARICE, INC., an Ohio corporation (the "Releasee"). The Releasor hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to take such other actions as may be reasonably requested by the Releasee to release and terminate any and all security interests and other liens in the Trademark Collateral, which shall be at the Releasee's sole expense.
