RELEASE OF TRADEMARK SECURITY INTERESTS

THIS RELEASE OF TRADMARK SECURITY INTEREST (this "Release") is made and effective as of April 19, 2021 (the "Effective Date") and granted by SILVERPEAK CREDIT PARTNERS LP, a limited partnership incorporated under the laws of Delaware, as "Collateral Agent", in favor of CORE SCIENTIFIC, INC., a Delaware corporation ("Core Scientific" or "Grantor"); and has reference to the following facts and circumstances (the "Recitals"):

- A. WHEREAS, Core Scientific, as the "Borrower", and certain subsidiaries of the Borrower party thereto (the Borrower together with the other Subsidiaries thereafter designated as Guarantors pursuant to Section 5.10 of the Credit Agreement, each a "Loan Party" and, collectively the "Loan Parties"), the lenders from time to time party thereto (each a "Lender" and, collectively, the "Lenders") and the Collateral Agent, have entered into a Credit and Guaranty Agreement, dated as of May 19, 2020 (as amended, amended and restated, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");
- B. **WHEREAS,** in connection with the Credit Agreement, the Loan Parties, including the Grantor, have entered into a Security Agreement, dated as of May 19, 2020 (as amended, amended and restated, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**") in favor of the Collateral Agent, for the benefit of the Secured Parties:
- C. WHEREAS, pursuant to the Security Agreement, Grantor pledged and granted to Collateral Agent a security interest in and to all of the right, title and interest of Core Scientific in, to and under its personal property, including all trademarks and trademark applications of Grantor including the trademarks and trademark applications therefor described in Exhibit A attached below (collectively, the "Trademark Collateral"), and a short form Trademark Security Agreement that was part of the Security Agreement was recorded with the United States Patent and Trademark Office on May 21, 2020, at Reel/Frame 6943/0797.
- D. WHEREAS, as a result of paying off the loan associated with the Credit Agreement and Security Agreement, Core Scientific requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to Core Scientific of any and all right, title and interest Collateral Agent may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent states as follows:

- 1. <u>Recitals</u>. The Recitals are true and correct, and, together with the defined terms set forth herein, are incorporated herein by this reference.
- 2. <u>Release of Security Interest.</u> Collateral Agent terminates the Credit Agreement, the Security Agreement, and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title and interest of the Trademark Collateral and reassigns to Core Scientific any and all right, title and interest that it may have, in, to and under the Trademark Collateral.
- 3. <u>Further Assurances</u>. Collateral Agent agrees, at Core Scientific's expense, to take all further actions, and provide to Core Scientific and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Core Scientific and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
- 4. <u>Governing Law.</u> The validity and interpretation of this Release and the rights and obligations of Core Scientific and Collateral Agent shall be governed by and construed in accordance with the substantive laws of the State of New York (without reference to conflict of law principles).

Collateral Agent executed this Release in favor of Core Scientific as of the Effective Date.
