Assignor hereby requests the Commissioner of Patents and Trademarks at the United States Patent and Trademark Office to record Assignee as the Assignee and owner of the Trademarks.

Assignor agrees on behalf of itself, its directors, officers, employees, agents, successors, assigns, and legal representatives to execute any and all papers and instruments and to do any and all acts which may be necessary or requested by Assignee, in order to carry into full force and effect this transfer and assignment.

This Assignment is binding upon, and inures to the benefit of, the parties and their respective successors and assigns. All questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware.


