TERMINATION AND RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

This Termination and Release of Second Lien Trademark Security Agreement (the "Release") is made as of April 26, 2021 (the "Release Date") by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Second Priority Collateral Agent (the "Collateral Agent"), for the benefit of BOYNE USA, INC., a Michigan corporation (the "Borrower") and certain Subsidiaries of the Borrower as identified on the signature pages to the Security Agreement referred to below (such Subsidiaries, collectively with the Borrower, the (the "Debtors" and each a "Debtor").

WHEREAS, the Debtors entered into that certain Second Lien Trademark Security Agreement, dated as of May 7, 2018 with the Collateral Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Security Agreement"), pursuant to which Debtors has granted to the Collateral Agent a security interest in all of such Debtors' right, title and interest in the Trademark Collateral, including, without limitation, the Trademark Collateral listed on Schedule 1 hereto (collectively, the "Trademarks");

WHEREAS, on May 11, 2018, the Security Agreement was filed with the United States Patent and Trademark Office (the "<u>USPTO</u>"), at Reel 006329, Frame 0516; and

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreement have been satisfied and the Debtors have requested that the Collateral Agent release its security interest in the Trademark Collateral, including, without limitation, the Trademarks.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

- 1. <u>Release of Security Interest</u>. Effective as of the Release Date, the Collateral Agent hereby irrevocably and forever terminates the Security Agreement and terminates, releases and discharges the entirety of its security interest and continuing lien on the Trademark Collateral, including, without limitation, the Trademarks.
- 2. <u>Recordation of Release</u>. The Collateral Agent understands and agrees that this Release may be recorded by or for the Debtor with the USPTO at the Debtors' sole cost and expense.
- 3. <u>Further Actions</u>. The Collateral Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors may reasonably require to effect the intent and purpose of this Release, <u>provided that</u> all such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.
- 4. <u>Capitalized Terms</u>. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement.
