**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of April 28, 2021 (this "Release") is made by Goldman Sachs BDC, Inc., acting in its capacity as collateral agent (in such capacity, the "Collateral Agent") under that certain Trademark Security Agreement, dated as of March 23, 2017 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") between Yasso, Inc. (the "Grantor") and the Collateral Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded on March 24, 2017 at Reel/Frame 6018/0428, the Grantor granted to the Collateral Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement and for purposes of this release, the "Released Collateral"), which includes those trademark registrations and applications set forth on the attached Schedule A; and


WHEREAS, the Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent, on its and the Secured Parties' (as that term is defined in the Trademark Security Agreement) behalf, does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate all of the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release all of its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
