Assignment and sale not been made; and TORGERSON agrees to execute such further documents as may be necessary or desirable to fully effectuate this Assignment.

AND, TORGERSON further grants to ACIEDOG, its successors and assigns, the right to claim the full benefit of said servicemarks under any international agreement between the United States and any foreign country or countries.

AND, TORGERSON does hereby authorize and request the Commissioner for Trademarks to record upon the records of the Trademark Office the Assignment made herein, to said ACIEDOG, and its successors and assigns, as assignee of the entire right, title and interest in and to the said servicemarks, their registrations, and the application, in addition to any goodwill symbolized by usage of the marks, for the sole use and behoof of said ACIEDOG, and for its successors and assigns, to the full length of the term for which any servicemark registration or its application may be granted.

TORGERSON also grants to ACIEDOG the right to enforce the servicemarks identified herein, to litigate any infringements that occurs relating to these marks, or may have been perpetrated in the past, as part of the grant of the title of these servicemarks to ACIEDOG.
