DEED OF ASSIGNMENT FOR INTELLECTUAL PROPERTY RIGHTS ("Assignment")

This Assignment is made this day of 14 AUG 2017 2017

BETWEEN

(1) MALAYSIAN AIRLINE SYSTEM BERHAD (Company No. 10601-W) (Administrator Appointed) of Ground Floor, Administrative Building 2, MAS Complex A, Sultan Abdul Aziz Shah Airport, 47200 Subang, Selangor Darul Ehsan (hereinafter referred to as the "Assignor") of the one part;

AND

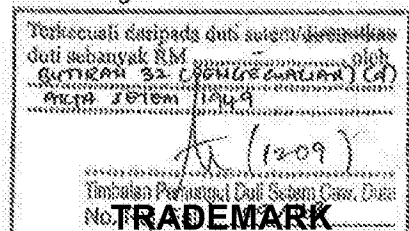
(2) MALAYSIA AIRLINES BERHAD (Company No. 1116944-X) of 1st Floor, Administration Building, Southern Support Zone, Kuala Lumpur International Airport, 64000 Sepang, Selangor Darul Ehsan (hereinafter referred to as the "Assignee") on the other part,

(each a "Party" and together the "Parties").

WHEREAS

1. The Parties have entered into a Sale of Assets and Liabilities Agreement dated 21 August 2015, pursuant to which the Assignee will acquire certain assets of the Assignor ("Sale of Assets and Liabilities Agreement", which expression shall include the amendments made pursuant to a letter dated 3 February 2016, supplemental agreement no. 2 dated 24 October 2016 and supplemental agreement no. 3 dated 14 AUG 2017 (Supplemental Agreement No. 3)).
2. Pursuant to the Sale of Assets and Liabilities Agreement, the Assignor agreed to sell, and the Assignee agreed to purchase all the Assignor's legal and beneficial rights, titles and interests in and to the trademarks and industrial designs.
3. The trademarks set out in Schedule A Part 1 are trademarks which are listed in the Sale of Assets and Liabilities Agreement and which have been vested in the Assignee pursuant to the Malaysian Airline System Berhad (Administration) (Vesting Date) Order 2015 ("Vesting Order") with effect from 1 September 2015.
4. The trademarks set out in Schedule A Part 2 are trademarks which are listed in the Sale of Assets and Liabilities Agreement and are to be assigned to the Assignee.
5. The trademarks set out in Schedule B Part 1 are the additional trademarks which are listed in the Supplemental Agreement No. 3, and are to be assigned to the Assignee.

6. The industrial designs set out in Schedule B Part 2 are the industrial designs which are listed in the Supplemental Agreement No. 3, and are to be assigned to the Assignee.
7. The Assignor is the proprietor and beneficial owner of the trademarks set out in Schedule A Part 2 and Schedule B Part 1, and the industrial designs set out in Schedule B Part 2 (collectively "Intellectual Properties").
8. The parties have agreed that the Intellectual Properties shall be assigned to the Assignee on terms and conditions set out below for good and valuable consideration effective from 1 September 2015.

NOW THIS ASSIGNMENT WITNESSETH as follows:

1. In consideration of the sum of *Ringgit Malaysia One only (MYR1.00)* now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges).
 - (a) unless otherwise agreed between the Assignor and the Assignee, the Assignor, as the proprietor and beneficial owner, hereby assigns and transfers absolutely to the Assignee all property, rights, title and interest, present and future, in the Intellectual Properties anywhere in the world, including:
 - (i) all statutory and common law rights attached thereto; and
 - (ii) the right to institute and maintain proceedings against any person and to retain absolutely any damages as a result of such action in respect of acts of infringement of the Intellectual Properties or passing off under common law prior to the date of this Assignment or hereafter.
 - (b) The Assignor confirms that this assignment is made with the goodwill attached to the Intellectual Properties and the goodwill of the business in which the Intellectual Properties have been used by the Assignor or relating to the services for which the Intellectual Properties have been applied and/or registered for in the relevant countries as set out in the Schedule A Part 2, Schedule B Part 1 and Schedule B Part 2.
2. The Assignor undertakes to execute all documents, papers, forms and authorisations and depose to or swear all declarations or oaths which the Assignee may reasonably require to secure, complete or absolutely vest full property, rights, title and interest in the Intellectual Properties in favour of the Assignee.

3. The Assignee is wholly responsible for making all necessary filings and paying all requisite fees, whether presently outstanding or payable in the future, to maintain the registrations of the Intellectual Properties in their respective territories and/or jurisdictions at the Assignee's own costs. Notwithstanding anything in this Assignment to the contrary, the property, rights, title and interest in Intellectual Properties are assigned and assumed on an "as is" basis with no representations or warranties, and the Assignor hereby excludes and disclaims any express or implied representations or warranties of any kind.
4. The Parties agree that the validity, construction and performance of this Assignment shall be governed in all respects by the laws of Malaysia. This Assignment shall take retrospective effect from 1 September 2015 irrespective of the date of execution by each Party.
5. No amendment, variation, revocation, cancellation, substitution or waiver of, or addition or supplement to, any of the provisions of this Assignment will be effective unless it is in writing and signed by the Parties.
6. It is hereby agreed that neither Dato' Mohammad Faiz Bin Mohammad Azmi of PricewaterhouseCoopers (the "Administrator") nor any person lawfully acting on behalf of the Administrator shall incur personal liability whatsoever in respect of any of the obligations undertaken by the Assignor, or in respect of any failure of on the part of the Assignor to observe, perform or comply with any such obligations; or under or in relation to any associated agreements or negotiations; or under any document or assurance made pursuant to this Assignment. The exclusion of liability set out in this clause shall arise and continue notwithstanding the termination of the appointment of the Administrator and shall operate as a waiver of any and all claims including, but not limited to, claims in tort, equity and common law as well as under the laws of contract.
7. This Assignment may be executed in counterparts.
8. This Assignment shall be binding upon and inure for the benefit of the successors-in-title or permitted assigns, as the case may be, of the Parties.
9. The Assignee shall be liable for all stamp duty payable on this Assignment and on any document executed pursuant to this Assignment.
