The Bank agrees to take all further actions, and provide to the Company and each of its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Company to more fully and effectively effectuate the purposes of this Release at the expense of the Company.




