SUPPLEMENT TO GRANT OF SECURITY INTEREST IN TRADEMARKS

This Supplement to the Trademark Security Agreement (this “Supplement”) is made as of the 20<sup>th</sup> day of May, 2021 by the undersigned party hereto (the “Grantor”), in favor of Wells Fargo Bank, National Association, as Collateral Agent (in such capacity, together with its successors and permitted assigns, “Collateral Agent”) for certain lenders and other secured parties.

WHEREAS, the Grantor (along with the other grantors party thereto) executed and delivered a Trademark Security Agreement, dated April 24, 2020 and recorded on April 24, 2020 at Reel 6923, Frame 0264 (as supplemented or amended of record from time to time hereinafter, the “Trademark Security Agreement”) in favor of the Collateral Agent, pursuant to which the Grantor (along with the other grantors party thereto) pledged, assigned and granted a security interest in favor of the Collateral Agent in certain Trademark Collateral (as defined therein); and

WHEREAS, the Grantor has developed additional Trademarks and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks as Trademark Collateral in favor of the Collateral Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Trademark Security Agreement.

  - a. Except as provided herein, all terms and conditions of the Trademark Security Agreement remain in full force and effect.
  - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
