TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made on April 30, 2021 by LENOX CORPORATION, a Delaware corporation, having an address at 1414 Radcliffe St., Bristol, PA 19007 (the "Assignor") for the benefit of FOOD52, INC., a Delaware corporation, having an address at 122 West 26th Street, 8th Floor, New York, NY 10001 (the "Assignee"). All capitalized terms used herein but not otherwise defined shall have the meanings given them in the Purchase Agreement (as defined below).

WHEREAS, Assignor and Assignee have entered into a certain Asset Purchase Agreement, dated as of April 30, 2021 (the "Purchase Agreement");

WHEREAS, Assignor is the owner of the right, title and interest in and to the Acquired Trademarks listed on Schedule A attached hereto, together with the goodwill of the business associated therewith; and

WHEREAS, pursuant to the Purchase Agreement, Assignee has agreed to sell, assign, transfer, convey and deliver to Assignee, among other things, all of Assignor's right, title and interest in and to the Acquired Trademarks.

NOW, THEREFORE, in consideration of the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignor hereby irrevocably sells, assigns and transfers to Assignee, its successors and assigns (a) all of Assignor's right, title and interest in and to the Acquired Trademarks, free and clear of all Liens other than Permitted Liens, together with the goodwill of the business being transferred to Assignee that is symbolized by, and connected with the use of, the Acquired Trademarks being assigned, as provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world, and the right to renew any registrations therefor, (b) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the Acquired Trademarks, and (c) all causes of action and rights and remedies at law or in equity for any and all past infringements, misappropriations, or other violations of the rights being assigned and the right to sue for, collect and retain all damages, profits, proceeds, and all other remedies associated therewith.

2. Assignor agrees to authorize and request the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of any and all of Assignor's rights in the Acquired Trademarks.

3. All of the terms and provisions of this Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

4. No provision of this Assignment is intended to confer upon any person other than the parties hereto and their respective successors and assigns any rights or remedies hereunder.

5. From time to time, as and when requested by any party, each party shall execute and deliver, or cause to be executed and delivered, all such documents and instruments and shall take, or cause to be taken, all such further or other actions, at such other party's cost and expense and as such other party may reasonably deem necessary consummate the transactions contemplated by the Purchase Agreement, including, in the case of Assignor, executing and delivering to Assignee such assignments, deeds, bills of sale, consents and other instruments as Assignee or its counsel may reasonably request as necessary to assure that all rights, titles and interests sold, assigned, and transferred hereunder are held and enjoyed by Assignee as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been executed.

6. This Assignment is executed and delivered pursuant to the Purchase Agreement and is subject in all respects to the terms and conditions of the Purchase Agreement and all of the representations, warranties, covenants and agreements of Assignor and Assignee contained therein, all of which shall survive the execution and delivery of this Assignment in accordance with the terms of the Purchase Agreement. Nothing contained in this Assignment shall be deemed to supersede, enlarge or modify any of the obligations, agreements, covenants, representations or warranties of Assignor and Assignee contained in the Purchase Agreement. Notwithstanding anything to the contrary contained in this Assignment, in the event of any conflict between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control.

7. This Assignment shall be governed by and interpreted and enforced in accordance with the laws of the State of New York, without giving effect to any choice of law or conflicts of laws rules or provision (whether of the State of New York or any other jurisdiction) that would cause the application of the laws of a jurisdiction other than the State of New York.



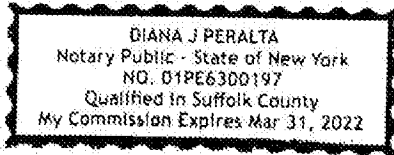
