Release of Security Interest

This Release of Security Interest (“Release”) is made and effective as of June 2, 2021 and granted by Silicon Valley Bank, a corporation of California (the “Bank”) in favor of ENSEO, LLC, as the successor in interest to ENSEO, INC., a limited liability company of Texas (the “Grantor”) and its successors, assigns and legal representatives. Capitalized terms not otherwise defined in this Agreement are being used in this Release as defined in the Loan and Security Agreement dated as of July 12, 2017 among the Grantor and Bank, as amended, restated, supplemented or otherwise modified from time to time (“Loan Agreement”).

WHEREAS, pursuant to Loan Agreement, the Grantor executed and delivered to the Bank that certain Intellectual Property Security Agreement by and between Grantor and Bank dated as of July 12, 2017 (the “Intellectual Property Security Agreement” and, together with the Loan Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, Grantor pledged and granted to Bank a security interest in and to all of the right, title and interest of such Grantor in, to and under the Intellectual Property (as defined below);

WHEREAS, the Intellectual Property Security Agreement was recorded with the Trademark Assignment Branch of the United States Patent and Trademark Office at Reel 6106, Frame 0428 on July 17, 2017 and recorded with the Patent Assignment Branch of United States Patent and Trademark Office at Reel 043210, Frame 0881 on July 17, 2017; and

WHEREAS, the Grantor has requested Bank enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest Bank may have in the Intellectual Property Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby states as follows:

1. Release of Security Interest. Bank, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the Intellectual Property Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the “Intellectual Property Collateral”):

(a) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (“Trademarks”);

(b) any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent

applications listed in Schedule 2 hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto, and all applications and patents claiming priority thereto or the benefit thereof (the "Patents");

(c) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) any and all license and other agreements in which such Grantor has granted or is granted a license or other right under any Trademark;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing;

(f) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; and

(g) any and all other rights, titles or interests provided by the Intellectual Property Security Agreement.

2. Further Assurances. Bank agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Texas, without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction).
