ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this “**Assignment**”) is executed and effective as of June 1, 2021 (the “**Effective Date**”) by and between SIERRA NEVADA CORPORATION, a Nevada corporation (the “**Assignor**”) and SIERRA SPACE CORPORATION, a Delaware corporation (the “**Company**”).

A. WHEREAS, the parties have entered into that certain Separation Agreement, that certain Contribution, Assignment, and Assumption Agreement, and that certain Intellectual Property Assignment Agreement (collectively, the “**Separation Agreements**”), each of even date herewith and executed by and between Assignor and Company;

B. WHEREAS, under the terms of the Separation Agreements, Assignor has sold, transferred, assigned, conveyed, and delivered to Company, among other assets, certain rights in trademarks, service marks and trade names, including, but not limited to, common law rights in these marks, as represented by the trademarks and their associated registrations and applications, including those described on Schedule A attached to and made a part of this Assignment (“**Trademarks**”); and

C. WHEREAS, the Assignor and Company are related companies, and Assignor desires to transfer the Trademarks, including, without limitation, all domestic and foreign rights, registrations and applications related thereto and all goodwill associated with and symbolized by the Trademarks, to the Company, as part of the business to which the Trademarks pertain, and the Company as a related company of Assignor desires to receive the Trademarks and all goodwill associated with and symbolized by the Trademarks, as a successor to the portion of Assignor’s business to which the Trademarks and associated goodwill pertain.

NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Assignment, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending legally to be bound, agree as follows:

1. Assignor hereby sells, assigns, transfers, conveys and delivers to the Company, its successors and assigns, the Assignor’s entire right, title and interest in and to (i) the Trademarks and all associated registrations and applications, both domestic and foreign, together with all goodwill associated with and symbolized by the Trademarks; and (ii) all past, present, and future claims, counterclaims, causes of action, rights or recourse of Assignor against third parties relating to the Trademarks, whether choate or inchoate, known or unknown, contingent or non-contingent.

2. The parties acknowledge and agree that this Assignment is entered into pursuant to the Separation Agreements. In the event of any conflict or inconsistency between the terms of the Separation Agreements and the terms hereof, the terms of the Separation Agreements shall govern.

3. This Assignment may be executed and delivered (including by facsimile or other electronic transmission (e.g., .pdf file)) in counterparts, and by the different parties hereto in


separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same document.

4. This Assignment shall be governed by the laws of the State of Colorado, without regard to its conflicts of law provisions. All disputes, controversies or claims (whether arising in contract, tort or otherwise) that may arise out of, relate to, arise under or in connection with, this Assignment shall be resolved in accordance with the resolution for disputes as agreed in the Separation Agreements.


