Government Employees Insurance Company ("GEICO"), GEICO Casualty Company ("GCC"), GEICO General Insurance Company ("GGIC"), GEICO Indemnity Company ("GIC") and GEICO Marine Insurance Company ("GMIC") (GEICO, GCC, GGIC, GIC AND GMIC are collectively referred to herein as "GEICO Companies") are all Maryland domiciled property and casualty insurance companies that have applied to the Director of Insurance of the State of Nebraska ("Director") for approval to change their domicile from Maryland to Nebraska. After reviewing the filings, correspondence, and all pertinent information provided to the Nebraska Department of Insurance ("Department"), the Director hereby approves the application and finds, concludes, and orders as follows:

## FINDINGS OF FACT

- 1. On or about December 13, 2020, the GEICO Companies filed applications and plans to redomesticate from Maryland to Nebraska pursuant to Neb. Rev. Stat. §§ 44-161 through 44-164 and the provisions of the Nebraska Model Business Corporation Act. Said applications and plans were supplemented as necessary throughout the Department's review process.
- GEICO is a Maryland domiciled property and casualty insurance company that first received its certificate of authority to transact the business of insurance in the State of Nebraska

first received its certificate of authority to transact the business of insurance in the State of Nebraska on August 19, 1983. GGIC is a Maryland domiciled property and casualty insurance company that first received its certificate of authority to transact the business of insurance in the State of Nebraska on December 19, 1978. GIC is a Maryland domiciled property and casualty

on June 18, 1950. GCC is a Maryland domiciled property and casualty insurance company that

insurance company that first received its certificate of authority to transact the business of

insurance in the State of Nebraska on June 19, 1986. GMIC is a Maryland domiciled property and

casualty insurance company that first received its certificate of authority to transact the business

of insurance in the State of Nebraska on September 28, 2009.

The GEICO Companies desire to change their domicile from Maryland to Nebraska

and the Board of Directors of each of the GEICO Companies have determined that it is in the best

interest of each of the GEICO Companies and their shareholders for the GEICO Companies to

become domestic insurance companies in the State of Nebraska. In particular, the GEICO

Companies desire to ease their administrative burden of mainting domiciles in two different states.

Three companies within the group of GEICO entities are presently domiciled in Nebraska, to wit:

GEICO Advantage Insurance Company, GEICO Choice Insurance Company and GEICO Secure

Insurance Company. Redomesticating the GEICO Companies to Nebraska results in all of the

insurance companies within the GEICO group being Nebraska domiciled insurers.

4. On December 23, 2020, the Maryland Insurance Administration issued a letter

indicating it has no objection to the GEICO Companies redomesticating to Nebraska.

5. The Board of Directors of each of the GEICO Companies approved this

redomestication on December 11, 2020 and will cause each of the GEICO Companies to file

Articles of Domestication, Amended and Restated Articles of Incorporation, and By-laws for each

of the GEICO Companies to effect the transfer of each of the GEICO Companies' domicile to Nebraska.

6. The shareholders for each of the GEICO Companies approved the redomestications

on December 11, 2020.

7. The GEICO Companies have submitted all documents, information and filings

required by Nebraska law and the Department, including the application, plan, Articles of

Domestication, Amended and Restated Articles of Incorporation, By-laws, and evidence of the

statutory trust deposit.

8. The redomestication to Nebraska is proposed to become effective at 8:00 A.M.,

Eastern Standard Time, on December 31, 2020.

CONCLUSIONS OF LAW

1. The State of Nebraska Department of Insurance has jurisdiction over the subject

matter and the parties to this transaction pursuant to Neb. Rev. Stat. §§ 44-101.01 and 44-161.

2. The approval of this application, Articles of Domestication, Amended and Restated

Articles of Incorporation, and By-laws will not, in any manner, impair the rights, remedies, or

security of any existing policyholders of the GEICO Companies.

The Articles of Domestication, Amended and Restated Articles of Incorporation,

and By-laws comply with the applicable Nebraska laws and should be approved.

4. After the redomestication, the GEICO Companies will meet all requirements for

holding a Certificate of Authority as Nebraska domestic property and casualty insurers.

5. The applications comply with all requirements of Nebraska law and should be

approved.

### ORDER

IT IS THEREFORE ORDERED that the applications of Government Employees Insurance Company, GEICO Casualty Company, GEICO General Insurance Company, GEICO Indemnity Company and GEICO Marine Insurance Company to transfer their domicile from Maryland to Nebraska are hereby approved.

The Nebraska Department of Insurance will issue Government Employees Insurance Company, GEICO Casualty Company, GEICO General Insurance Company, GEICO Indemnity Company and GEICO Marine Insurance Company certificates of authority to do the business of insurance as domestic property and casualty insurers in the State of Nebraska.
