RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This **RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of June 14, 2021 (this “Release”) by Citibank, N.A., as Administrative Agent for the benefit of the Secured Parties (in such capacity, the “Administrative Agent”), in favor of GrubHub Holdings Inc., GrubHub Inc., Slick City Media, Inc., DiningIn LLC, Restaurants on the Run, LLC, Mealport USA LLC, Mealport DEN, LLC, Mealport PDX, LLC, Mealport SAN LLC, Mealport EUG LLC, Mealport ABQ, LLC, Mealport ELP, LLC, Mealport LAS LLC, KMLEE Investments Inc, Thresher Logistics LLC, Bite Commissary LLC, LAbite.com, Inc., KFCC Consulting LLC, KFCO LLC, Foodler Acquisition LLC, Eat24, LLC, Homecooked Factory LLC (each, individually, an “Original Grantor”, and, collectively, the “Original Grantors”), SCVNGR, Inc. (“SCVNGR”), and Tapingo, Inc. (“Tapingo”, and together with the Original Grantors and SCVNGR, each, individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the IP Security Agreements (as defined below).

WHEREAS, (a) the Administrative Agent and the Original Grantors are party to that certain Intellectual Property Security Agreement, dated as of October 10, 2017 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “Original IP Security Agreement”); (b) the Administrative Agent and SCVNGR, Inc. are party to that certain Intellectual Property Security Agreement, dated as of October 26, 2018 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “SCVNGR IP Security Agreement”); (c) the Administrative Agent and Tapingo, Inc. are party to that certain Intellectual Property Security Agreement, dated as of February 5, 2019 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “Tapingo IP Security Agreement”); (d) GrubHub Holdings Inc. and the Administrative Agent are party to that certain Intellectual Property Security Agreement, dated as of February 5, 2019 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “GH 2019 IP Security Agreement”); and (e) the Administrative Agent and Eat24, LLC are party to that certain Intellectual Property Security Agreement, dated as of February 5, 2019 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “Eat24 2019 IP Security Agreement”, and together with the Original IP Security Agreement, the SCVNGR IP Security Agreement, the Tapingo IP Security Agreement, and the GH 2019 IP Security Agreement, the “IP Security Agreements”);

WHEREAS, pursuant to the terms and conditions of the IP Security Agreements, the Grantors granted to the Administrative Agent, for its benefit and for the ratable benefit of each of the Secured Parties, a security interest in all of the Grantors’ right, title, and interest in and to the following, wherever located and whether now or hereafter existing or acquired (collectively, the “Trademark Collateral”):

(i) (a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, service marks, certification marks, collective marks, logos, all Internet domain names and associated URL addresses in or to which the Grantor now or hereafter has any right, title or interest, other source of business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of a like nature (all of the foregoing items in this clause (a) being collectively called a “Trademark”), now existing anywhere in the world or hereafter adopted or acquired, whether currently in use or not, all registrations and recordings thereof (including all renewals thereof) and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any foreign country, including those referred to in Item A of Schedule A attached hereto; (b) all Trademark licenses, including each non-ordinary course Trademark license referred to in Item B of Schedule

A attached hereto; (c) all reissues, extensions or renewals of any of the items described in clauses (a) and (b) above; (d) all of the product lines and goodwill of the business connected with the use of, and symbolized by the items described in, clauses (a) and (b) above; and (e) all rights associated with the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, including any Trademark, Trademark registration or non-ordinary course Trademark license referred to in Item B of Schedule A attached hereto, or for any injury to the goodwill associated with the use of any such Trademark or for breach or enforcement of any Trademark license; provided that the Trademark Collateral does not and shall not include any Trademark that would be rendered invalid, abandoned, void or unenforceable by reason of it being included as part of the Trademark Collateral; and

(ii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds and revenues from any claim by any such Grantor against third parties for past, present or future unfair competition with, or violation of intellectual property rights in connection with or injury to, or infringement or dilution of, any Trademark owned by any such Grantor (including, without limitation, any United States trademark identified on Schedule A hereto);

WHEREAS, (a) the Original IP Security Agreement was recorded with the United States Patent and Trademark Office on October 30, 2017 at Reel/Frame 006192/0633; (b) the SCVNGR IP Security Agreement was recorded with the United States Patent and Trademark Office on October 29, 2018 at Reel/Frame 6469/0269; (c) the Tapingo IP Security Agreement was recorded with the United States Patent and Trademark Office on February 5, 2019 at Reel/Frame 6551/0698; (d) the GH 2019 IP Security Agreement was recorded with the United States Patent and Trademark Office on February 5, 2019 at Reel/Frame 6551/0672; and (e) the Eat24 2019 IP Security Agreement was recorded with the United States Patent and Trademark Office on February 5, 2019 at Reel/Frame 6551/0655 ; and

WHEREAS, the Administrative Agent has agreed to terminate and release the security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Administrative Agent hereby terminates and releases in its entirety its security interest and lien in all of the Grantors' right, title, and interest in, to and under the Trademark Collateral, and reassigns to each Grantor any and all such right, title and interest in such Trademark Collateral, free and clear of all such security interest and lien.

2. To the extent the Administrative Agent retains any such interest, the Administrative Agent hereby assigns, transfers and conveys to the Grantors all of the Administrative Agent's right, title and interest, now owned or hereinafter acquired, that it may have, whether by assignment or otherwise, in and to any mortgage and continuing security interest in the Trademark Collateral, including, without limitation, the entire right, title and interest in and to the Trademark Collateral, all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto and the goodwill of the business to which the Trademark Collateral relates. Such assignment, transfer and conveyance by the Administrative Agent is made without any representation or warranty (express or implied) by the Administrative Agent, except that the Administrative Agent has not transferred or conveyed any interest therein.

3. This Release may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Delivery by telecopier, .pdf or other electronic imaging means of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.

4. The Administrative Agent authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.

5. THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL EACH BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
