## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this “Assignment”), is dated and effective as of June 16, 2017, by and among DISPENSING DYNAMICS INTERNATIONAL, LLC, a California limited liability company (“DDI”), and AWAY FROM HOME ACQUISITION COMPANY, a Delaware corporation (the “Assignee”).

WHEREAS, DDI has conveyed, transferred and assigned all of DDI’s right, title and interest in the trademarks listed in Schedule 1 to this Agreement, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, trademark applications and registrations, and the right to recover for past infringement worldwide, and including all goodwill associated with and symbolized by such trademarks (collectively, the “Trademark Rights”) to Assignee and has agreed to execute and deliver this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. Assignment. DDI hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts, all of DDI’s right, title and interest in and to the following:

(a) the Trademark Rights;

(b) all rights of any kind whatsoever of DDI accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; and

(c) any and all rights to sue and collect damages, royalties and payments for past, present and future infringement, misappropriation or other violation thereof.

2. Recordation. DDI, on its behalf and on behalf of its subsidiaries, authorizes the Commissioner for Trademarks and any other trademark offices and other similar authorities anywhere in the world to record and register this Assignment upon request by Assignee. As between the parties, Assignee shall be responsible, at its sole cost and expense, for all applicable recordations (and preparation of such recordations and other applicable instruments of transfer or assignment) of the assignment or transfer of the Trademark Rights.

3. Counterparts and Execution. This Assignment may be executed in two or more counterparts, all of which when taken together will be considered one and the same agreement and will become effective when counterparts have been signed by each party hereto and delivered to the other party, it being understood that all parties need not sign the same counterpart. In the event that any signature is delivered by facsimile transmission or by e-mail

delivery of a “.pdf” format data file, such signature will create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or “.pdf” signature page were an original thereof.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto their respective successors and assigns.
