FOURTH: The executed Agreement of Merger is on file at an office of the Surviving Corporation, 4901 Kesslersville Road, Easton, PA 18040.


FIFTH: A copy of the Agreement of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either constituent corporation.
