**ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY
AGREEMENT**

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY AGREEMENT (“Agreement”) dated as of June 18, 2021 (the “Effective Date”), is made by and between CITIBANK, N.A. (the “Assignor”), the predecessor or retiring Primary Administrative Agent and Collateral Agent (in such capacities, the “Predecessor Agent”) under the Credit Agreement (as defined below), and MIDCAP FUNDING IV TRUST (the “Assignee”), as the successor Primary Administrative Agent and Collateral Agent.

WHEREAS, Assignor entered into that certain Asset-Based Revolving Credit Agreement dated as of September 7, 2016 by and among Revlon, Inc., a Delaware corporation, Revlon Consumer Products Corporation, a Delaware corporation, the lenders and issuing lenders party thereto, and Citibank, N.A., as administrative agent for the Lenders, collateral agent for the Secured Parties, issuing lender and swingline lender (as amended as of April 17, 2018; March 6, 2019; April 17, 2020; May 7, 2020; October 23, 2020; December 21, 2020 and March 8, 2021, and as further amended, amended and restated, supplemented or otherwise modified prior to the Effective Date, the “Credit Agreement”);

WHEREAS, the Assignor, as the collateral agent under those certain short form intellectual property security agreements identified on Schedule A hereto (each as amended, modified, restated or supplemented, the “Security Agreements”), has been granted security interests in certain intellectual property identified in such Security Agreements, including the intellectual property identified on Schedule B attached hereto (collectively, the “Intellectual Property Collateral”);

WHEREAS, the Assignor and the Assignee have entered into that certain Successor Agent Appointment and Agency Transfer Agreement, dated and effective as of May 7, 2021 (the “Assignment Agreement”), pursuant to which the Assignor as the Predecessor Agent has resigned as Primary Administrative Agent and Collateral Agent under the Credit Agreement and the other Loan Documents and the Assignee has been appointed as successor Primary Administrative Agent and Collateral Agent under the Credit Agreement and the other Loan Documents (in such capacities, the “Successor Agent”);

WHEREAS, as of the Effective Date, pursuant to the terms of the Assignment Agreement, the Predecessor Agent assigned to the Successor Agent the security interests granted to the Predecessor Agent under the Credit Agreement and other Loan Documents, and the Successor Agent assumed all such security interests, for its benefit and for the benefit of the Secured Parties; and

WHEREAS, capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Assignment Agreement or Security Agreements, as applicable.

NOW, THEREFORE, in consideration of the premises and covenants set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby confirms that all right, title and interest in and to the security interests granted to the Assignor, in its capacity as the Predecessor Agent, under the Credit Agreement and other Loan Documents, including, without limitation, the security interest granted to the Assignor in the Intellectual Property Collateral, have been conveyed, assigned and transferred to Assignee, in its capacity as the Successor Agent, and its successors and permitted assigns, and to the extent that any such right, title or interest has not been so conveyed, assigned and transferred, Assignor, in its capacity as the Predecessor Agent, hereby conveys, assigns and transfers to Assignee, in its capacity as the Successor Agent, all such right, title and interest in and to such security interests in the Intellectual Property Collateral (the "Assignment"), and in connection therewith, Assignor does hereby release, relinquish, terminate, cancel and discharge all of its right, title and interest in and to the Intellectual Property Collateral.

2. Purpose. This Agreement has been executed and delivered by the Assignor for the purpose of recording this Agreement with the United States Patent and Trademark Office and the United States Copyright Office to evidence the Assignment. The Assignment confirmed herein has been assigned in connection with the Assignment Agreement and is expressly subject to the terms and conditions thereof. In the event of any conflict between the terms of this Agreement and the terms of the Assignment Agreement, the terms of the Assignment Agreement shall control.

3. Further Assurances. The Predecessor Agent agrees that, on and after the Effective Date, in each case at the Borrower's expense, the Predecessor Agent shall take such actions as may be reasonably requested by the Successor Agent from time to time in order to effect and evidence the matters covered hereby.

4. Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.

5. APPLICABLE LAW. THE VALIDITY, INTERPRETATION AND ENFORCEMENT OF THIS AGREEMENT AND ANY DISPUTE ARISING OUT OF THE RELATIONSHIP BETWEEN THE PARTIES HERETO, WHETHER IN CONTRACT, TORT, EQUITY OR OTHERWISE, SHALL BE GOVERNED BY THE INTERNAL LAWS OF THE STATE OF NEW YORK BUT EXCLUDING ANY PRINCIPLES OF CONFLICTS OF LAW OR OTHER RULE OF LAW THAT WOULD CAUSE THE APPLICATION OF THE LAW OF ANY JURISDICTION OTHER THAN THE LAWS OF THE STATE OF NEW YORK.

6. WAIVER OF RIGHT TO TRIAL BY JURY. EACH PARTY HERETO HEREBY WAIVES ANY RIGHT TO TRIAL BY JURY OF ANY CLAIM, DEMAND, ACTION OR CAUSE OF ACTION ARISING UNDER THIS AGREEMENT OR ANY OF THE OTHER LOAN DOCUMENTS OR IN ANY WAY CONNECTED WITH OR RELATED OR INCIDENTAL TO THE DEALINGS OF THE PARTIES HERETO IN RESPECT OF THIS AGREEMENT OR ANY OF THE OTHER LOAN DOCUMENTS OR THE TRANSACTIONS RELATED HERETO OR THERETO IN EACH CASE WHETHER NOW EXISTING OR

HEREAFTER ARISING, AND WHETHER IN CONTRACT, TORT, EQUITY OR OTHERWISE. EACH PARTY HERETO HEREBY AGREES AND CONSENTS THAT ANY SUCH CLAIM, DEMAND, ACTION OR CAUSE OF ACTION SHALL BE DECIDED BY COURT TRIAL WITHOUT A JURY AND THAT ANY PARTY HERETO MAY FILE A COPY OF THIS AGREEMENT WITH ANY COURT AS WRITTEN EVIDENCE OF THE CONSENT OF THE PARTIES HERETO TO THE WAIVER OF THEIR RIGHT TO TRIAL BY JURY.


