**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this “**Assignment**”), dated as of June 16, 2021 (the “**Effective Date**”), is made by JH Global IP Limited, a corporation registered under the laws of the British Virgin Islands and having its principal registered office located at Ritter House, Wickhams Cay II, Road Town, Tortola VG1110, British Virgin Islands (“**Assignor**”) and John Hardy (HK) Limited, a corporation registered under the laws of Hong Kong and having its principal registered office located at 3806 Central Plaza, 18 Harbour Road, Wanchai, Hong Kong (“**Assignee**”).

**WHEREAS**, Assignor and Assignee entered into that certain Intellectual Property Assignment Agreement dated as of the Effective Date (“**Omnibus Agreement**”), pursuant to which Assignor assigned, conveyed and transferred to Assignee as a contribution to the share capital of Assignee, and Assignee acquired and received as a contribution to its share capital, any and all of the intellectual property rights owned or held by Assignor, including, without limitation, any and all of the intellectual property rights owned or held by Assignor, including, without limitation, any and all of those rights owned or held by Assignor on the Effective Date, as well as any and all intellectual property rights which may be owned, held, created, developed or otherwise acquired by Assignor thereafter, if any (collectively, the “**Transferred IP**”); and

**WHEREAS**, Assignor wishes to assign, convey and transfer to Assignee any and all of Assignor’s entire right, title and interest in and to the trademarks, service marks, names, corporate names, trade names, domain names, social media accounts and usernames, logos, slogans, trade dress, design rights, and other similar designations of source or origin, together with any applications and registrations therefor (including any common law rights that may exist and are associated therewith) and together with any and all goodwill attaching to and/or symbolized by any of the foregoing, including, without limitation, those trademark registrations and trademark applications, set forth on Schedule A hereto (the “**Trademarks**”), but subject in all respects to the security interests and other rights granted in respect of any such Trademarks under the Security Agreements as hereinafter defined.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, which are considered to be good and valuable consideration for purposes of the Assignment:

1. Assignor agrees to assign, transfer and convey, and does hereby assign, transfer and convey to Assignee and its successors and assigns, any and all of Assignor’s entire right, title, and interest in and to the Trademarks, and Assignee hereby accepts such assignment, transfer and conveyance of the Trademarks, including, without limitation, those set forth on Schedule A hereto, but subject in all respects to the security interests and other rights granted in respect of the Trademarks to (i) Cortland Capital Market Services LLC, as Administrative Agent (“**Cortland**”) under that certain Guarantee and Collateral Agreement by and among JH Global Holdings Limited, JH Investment Holdings Limited, Assignor, the other Subsidiaries as referred to therein, and Cortland, and the Patent Security Agreement, Trademark Security Agreement and Copyright Security Agreement referred to

therein, each dated as of January 30, 2018; (ii) Cortland under that certain Trademark Security Agreement and Copyright Security Agreement dated as of June 30, 2020 and July 17, 2020, respectively by and among JH Global Holdings Limited, Assignor, the other Subsidiary Loan Parties referred to therein and Cortland and (iii) HSBC Bank USA, National Association, as Administrative Agent (“**HSBC**”) under that certain Guarantee and Collateral Agreement by and among JH Investment Holdings Limited, JH Global Holdings Limited, John Hardy USA, Inc., Assignor, the other Subsidiary Loan Parties referred to therein and HSBC, and the Patent Security Agreement, Trademark Security Agreement and Copyright Security Agreement referred to therein, each dated as of January 30, 2018 (collectively, the “**Security Agreements**”), and Assignee hereby accepts such assignment, transfer and conveyance, all of the same to be held and enjoyed by Assignee for its own use and for the use of its successors or assigns as fully and entirely as the same would have been enjoyed by Assignor, if assignment thereof had not been made.

2. Assignee shall bear all costs and expenses of Assignor relating to the transfer of the Trademarks contemplated herein. Assignee acknowledges and agrees that its rights under the Trademarks are subject to the applicable terms of the Security Agreements.
3. Assignor does hereby authorize the United States Patent and Trademark Office and any other trademark office or similar or comparable agency, office, register or registrar in any country or jurisdiction to record Assignee as the owner (or applicant, as applicable) of the Trademarks in accordance with the terms of this Assignment, and to issue any such registration, certificate or document in such country or jurisdiction in the name and for the benefit of Assignee.
4. Assignor agrees to provide cooperation and assistance to Assignee and its successors, assigns and legal representatives and perform upon written request and at Assignee’s expense any and all lawful acts (including timely executing and delivering, or causing those under its direct control to timely execute and deliver, any and all documents) that may be reasonably necessary to record the assignment and transfer of the Trademarks with the United States Patent and Trademark Office and any other trademark office or similar or comparable agency, office, register or registrar in any country or jurisdiction. At Assignee’s expense, Assignor shall also timely execute and deliver all documents, papers, forms and authorizations, and perform all actions necessary to give full effect to this Assignment, and assist Assignee in evidencing, obtaining, perfecting, maintaining, defending and enforcing the Trademarks.
5. Assignee and Assignor also agree that this Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together constitute one and the same instrument, and each of which shall be valid and binding upon Assignee and Assignor.
6. This Assignment shall be governed under the laws of the State of New York, excluding its rules governing conflicts of laws that may require an application of a different law.

7. This Assignment shall be binding upon and inure to the benefit of Assignor, Assignee and their respective successors and assigns.
8. If any provision of this Assignment is determined by a court of competent jurisdiction to be invalid, illegal or unenforceable, the remaining provisions of this Assignment remain in full force, if the essential terms and conditions of this Assignment for each party remain valid, binding and enforceable. Assignor and Assignee shall then use all reasonable endeavors to replace the invalid or unenforceable provision(s) by a valid, legal and enforceable substitute provision the effect of which is as close as possible to the intended effect of the invalid, illegal or unenforceable provision.
9. This Assignment constitutes the final agreement by and between Assignor and Assignee, and is the complete and exclusive statement of their agreement on the matters contained herein. All prior and contemporaneous negotiations and agreements between Assignor and Assignee with respect to the matters contained herein are superseded by this Assignment.
10. This Assignment may not be amended, supplemented or otherwise modified except by a written instrument executed by each of Assignor and Assignee.


