TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS is entered into as of May 12, 2021 (this "Release") by JPMorgan Chase Bank, N.A. as administrative agent (the "Agent") in favor of ICON HEALTH & FITNESS, INC. and ICON IP, Inc. (collectively, the "Grantor").

Reference is made to the Pledge and Security Agreement dated as of April 27, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among Holdings, the Grantor, the other Loan Parties party thereto and the Agent, pursuant to which the Grantor and the Agent entered into the Trademark Security Agreement dated as of April 27, 2020 (the "Trademark Security Agreement"), recorded by the U.S. Patent and Trademark Office (the "USPTO") on May 14, 2020 at Reel/Frame 6939/0347 and the Canadian Intellectual Property Office ("CIPO") on July 14, 2020.

Under the Trademark Security Agreement, as security for the payment in full of the Obligations, the Grantor pursuant to the Security Agreement, granted to the Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in, to and under the Trademark Collateral set forth on Schedule I attached hereto. The Agent has agreed to terminate and release the entirety of its security interest in and to the Trademark Collateral set forth on Schedule I. Accordingly, the parties hereto agree as follows:

SECTION 1. <u>Terms</u>. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Security Agreement or the Trademark Security Agreement, as applicable.

SECTION 2. <u>Release of Security Interest</u>. The Agent, without representation, covenant or warranty, express or implied, and without recourse to the Agent, hereby terminates, cancels and releases its security interest in all of the Trademark Collateral set forth on <u>Schedule I</u>.

SECTION 3. <u>Authorization; Further Assurances</u>. The Agent hereby authorizes the Grantor to record this Release with the USPTO and CIPO. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to take such other actions as may be reasonably requested by the Grantor to release and terminate any and all security interests and other liens in the Trademark Collateral set forth on <u>Schedule I</u>, which shall be at the Grantor's sole expense.
