#### INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of June 30, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, this "Agreement"), by IZOTOPE, INC., a Delaware corporation (the "Grantor") in favor of LUCID TRUSTEE SERVICES LIMITED, a company incorporated under the laws of England and Wales, as security trustee for the Secured Parties (the "Security Agent") (as defined in the Facilities Agreement referred to below).

Reference is made to that certain (i) US Security Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantor, the debtors party thereto, and the Security Agent, pursuant to which the Grantor granted a security interest to the Security Agent in the IP Collateral (as defined below) and are required to execute and deliver this Agreement, and (ii) Senior Facilities Agreement, dated as of February 23, 2021 (as amended, restated and/or supplemented from time to time, the "Facilities Agreement"), among Aptus 1716. GMBH, the Original Borrower, the Original Guarantors party thereto, the financial institutions party thereto, Lucid Agency Services Limited, as agent, and the Security Agent. Consistent with the requirements set forth in Schedule 2 (Conditions Precedent), Part 2 (Conditions precedent required to be delivered by an Additional Guarantor), Item 10 of the Facilities Agreement, and Section 3(d) of the Security Agreement, the parties hereto agree as follows:

SECTION 1. **Terms**. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement or the Facilities Agreement, as applicable.

SECTION 2. **Grant of Security Interest**. As security for the prompt and complete payment or performance, as the case may be, in full of the Secured Obligations (as defined in the Intercreditor Agreement), the Grantor, pursuant to the Security Agreement, hereby pledges and grants to the Security Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a lien on and security interest in all of its right, title and interest in and to all of the following personal property, whether now owned by or owing to or hereafter acquired by or arising in favor of the Grantor (collectively, the "IP Collateral"; provided, however, that notwithstanding anything to the contrary in this Agreement, the IP Collateral shall not include any Excluded Property):

- A. all Trademark registrations and applications for Trademark registration and all licenses thereof in the United States Patent and Trademark Office listed on <u>Schedule I</u> hereto, including all goodwill associated with or symbolized by the Trademarks;
- B. all issued Patents and pending Patent applications and all licenses thereof in the United States Patent and Trademark Office listed on <u>Schedule II</u> hereto;
- C. all Copyright registrations and pending applications for Copyright registration and licenses thereof in the United States Copyright Office listed on <u>Schedule III</u>;
- D. the right to sue at law or in equity third parties for past, present and future infringements, impairments or dilutions of any IP Collateral; and
  - E. all proceeds of the foregoing;

in each case to the extent the foregoing items constitute Collateral, it being expressly understood and agreed that the term "Collateral" (and any component definition thereof) shall not include any Excluded Property.

SECTION 3. *Future IP Collateral*. The Grantor hereby authorizes Security Agent to modify this Agreement by amending <u>Schedule II</u>, <u>Schedule II</u> or <u>Schedule III</u> to include any future IP Collateral and the Grantor agrees to execute any agreements, documents or instruments reasonably requested by Security Agent to effectuate such amendment.

SECTION 4. Security Agreement. The security interests granted to the Security Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Security Agent pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the IP Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 5. *Governing Law*. This Agreement and any claim, controversy or dispute arising under or related to this Agreement, whether in tort, contract (at law or in equity) or otherwise, shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York without regard to conflict of laws principles that would result in the application of any law other than the law of the State of New York.

SECTION 6. *Termination or Release*. This Agreement shall continue in effect until termination of the Security Agreement, and on such date the security interest granted by the Grantor hereunder shall be automatically released and the Grantor shall automatically be released from its obligations hereunder, and the Security Agent shall take such actions as requested by the Grantor in accordance with Section 11 of the Security Agreement.

SECTION 7. *Counterparts*. This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or by email as a ".pdf" or ".tif" attachment shall be effective as delivery of a manually executed counterpart of this Agreement.
