**TERMINATION AND RELEASE OF
SECURITY INTERESTS IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interests in Intellectual Property (the "Termination and Release") is granted, as of June 29, 2021, by the Agent (as hereinafter defined) to each of the Grantors (as hereinafter defined).

WITNESSETH:

WHEREAS, in connection with that certain Credit and Security Agreement, dated October 23, 2019, by and among TeleTracking Technologies, Inc., a Delaware corporation ("Grantor"), and The Huntington National Bank, in its capacity as administrative agent for the Banks thereunder (hereinafter referred to in such capacity as the "Agent") (as amended, restated, modified or supplemented from time to time, the "Credit Agreement") and pursuant to that certain Patent, Trademark and Copyright Security Agreement, effective as of October 23, 2019, by and among the Agent and the Grantor (as amended, restated, modified or supplemented from time to time, the "IP Security Agreement"), Grantor, as applicable, granted security interests (the "Security Interests") to the Agent in the Collateral (as hereinafter defined) of the Grantor, as applicable; and

WHEREAS, the Security Interests were recorded in the United States Patent and Trademark Office on October 23, 2019, at Reel 050809, Frame 0535-0563 and Reel 006778, Frame 0034-0046, respectively; and recorded on September 10, 2020, at Reel 053753, Frame 0001-0027 and Reel 007048, Frame 0696-0709, respectively.

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interests in the Collateral owned by Grantor, as applicable;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Collateral: The term "Collateral," as used herein, shall mean all of each of the Grantors' respective right, title and interest in and to the following:
 - (i) the patents and patent applications set forth in Schedule A attached hereto (collectively, the "Patents");
 - (ii) the trademark and service mark registrations and applications set forth in Schedule B attached hereto, together with the goodwill symbolized thereby (the "Trademarks");
 - (iii) all copyrights, whether registered or unregistered, set forth in Schedule C attached hereto, together with any copyrights, whether registered or

unregistered, hereafter acquired by the Grantor, as applicable (the "Copyrights");

- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor, as applicable, accruing thereunder or pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and *future infringement, dilution, misappropriation, violation, misuse or breach* with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral or arising from any of the foregoing.

2. Release of Security Interests: The Agent hereby terminates, releases and discharges its Security Interests in the Collateral, and any right, title or interest of the Agent in such Collateral shall hereby immediately cease and become void.

3. Authorization: The Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office, as well as the intellectual property offices of any other jurisdictions where any Collateral is registered, to release the above-referenced Security Interests.

4. Further Assurances: At the request and sole expense of Grantor, the Agent shall execute and deliver to the Grantor any such additional documents as Grantor may reasonably request to evidence the termination and release of the Security Interests.

5. Miscellaneous. Capitalized terms used and not otherwise defined herein shall have the meaning ascribed to such terms in the Credit Agreement and/or the IP Security Agreement, as applicable, to the extent defined therein.
