THIS DEED is dated

31st December 2020

BETWEEN

- (1) **SHAUN PULFREY** of 37 Turret Grove LONDON SW4 ES, UK (the "**Individual**"); and
- (2) **TANGLE TEEZER LIMITED**, incorporated and registered in England and Wales with company number 05396577 whose registered office is at 205 1st And 2nd Floor, 205 Stockwell Road, London, England, SW9 9SL ("**Tangle Teezer**"),

each a "**Party**" and together the "**Parties**".

BACKGROUND

- (A) The Individual is the founder of Tangle Teezer and, in his personal capacity, has developed and/or owns various Intellectual Property Rights (as defined below) in relation to the Tangle Teezer hairbrushes and brand (the "**Intellectual Property**").
- (B) Under a licence agreement between the Individual and Tangle Teezer dated 4 February 2013, the Individual granted Tangle Teezer an exclusive, worldwide licence to use the Intellectual Property.
- (C) The Parties now wish to transfer the Assigned Rights (as defined below) in the Intellectual Property to Tangle Teezer.

AGREED TERMS

1 INTERPRETATION

The following definitions and rules of interpretation apply in this Agreement.

1.1 Definitions:

"**Agreement**" means this deed of assignment;

"**Assigned Rights**" means the Patents, Trade Marks and Registered Designs and all the Intellectual Property Rights set out in Schedule 5;

"**Business Day**" means a day other than a Saturday, Sunday or public holiday in England when banks in London are open for business;

"**Effective Date**" means the date of this Agreement;

"**Intellectual Property**" has the meaning given to it in Recital A;

"**Intellectual Property Rights**" means patents, utility models, rights to inventions, copyright and neighbouring and related rights, trade marks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world;

"**Patents**" means the patents and the applications short particulars of which are set out in Schedule 1;

"**Registered Designs**" means the registered designs and the applications short particulars of which are set out in Schedule 2;

"Trade Marks" means the registered trade marks and the applications and the unregistered trade marks and trade names short particulars of which are set out in Schedule 3; and

"VAT" means value added tax or any equivalent tax chargeable in the UK or elsewhere.

- 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this Agreement.
- 1.3 A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 The Schedules form part of this Agreement and shall have effect as if set out in full in the body of this Agreement. Any reference to this Agreement includes the Schedules.
- 1.5 References to Clauses and Schedules are to the Clauses and Schedules of this Agreement.
- 1.6 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.7 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.8 This Agreement shall be binding on, and ensure to the benefit of, the Parties and their respective personal representatives, successors and permitted assigns, and references to any Party shall include that Party's personal representatives, successors and permitted assigns.
- 1.9 A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time.
- 1.10 A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- 1.11 A reference to **writing** or **written** includes email but not fax.
- 1.12 Any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

2 ASSIGNMENT

- 2.1 In consideration of the sum of [REDACTED] (receipt of which the Individual expressly acknowledges), with effect from the Effective Date, the individual hereby assigns to Tangle Teezer absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights, including:
- (a) the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Patents, Registered Designs and Trade Marks;
 - (b) all goodwill attaching to the Trade Marks; and
 - (c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights whether occurring before, on, or after the date of this Agreement.

3 VAT

- 3.1 All payments made by Tangle Teezer under this Agreement are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or

deemed taxable supply by the Individual, Tangle Teezer shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply, provided that the Individual shall have delivered a valid VAT invoice in respect of such VAT to Tangle Teezer.

4 WARRANTIES AND OBLIGATIONS

4.1 The Individual warrants that:

- (a) he is the sole legal and beneficial owner of, and owns all the rights and interests in, the Assigned Rights;
- (b) for each of the applications and registrations listed in Schedule 1, Schedule 2 and Schedule 3 he is properly registered as the applicant or registered proprietor, and all application, registration and renewal fees have been paid;
- (c) he has not licensed or assigned any of the Assigned Rights except as set out in Schedule 4; and
- (d) the Assigned Rights are free from any security interest, option, mortgage, charge or lien except as set out in Schedule 4.

5 FURTHER ASSURANCE

5.1 At his own expense the Individual shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform all such acts as may be required for the purpose of giving full effect to this Agreement, including:

- (a) any additional Intellectual Property Right assignments as may be necessary to transfer ownership of any Intellectual Property Rights that were not transferred under this Agreement but should have been in order to ensure transfer of all Intellectual Property Rights that Tangle Teezer requires to carry on the Tangle Teezer business as it is carried out up to and on the Commencement Date and in accordance with any plans and proposals in place;
- (b) registration of Tangle Teezer as applicant or (as applicable) proprietor of the Assigned Rights, including all associated documents (such as, but not limited to, notarisation, translations, power of attorneys, additional short-form bi-lingual assignment agreements and legalisation); and
- (c) assisting Tangle Teezer in obtaining, defending and enforcing the Assigned Rights, and assisting with any other proceedings which may be brought by or against Tangle Teezer against or by any third party relating to the Assigned Rights.

5.2 The Individual appoints Tangle Teezer to be its attorney in its name and on its behalf to execute documents, use the Individual's name and do all things which are necessary or desirable for Tangle Teezer to obtain for itself or its nominee the full benefit of this Agreement.

5.3 This power of attorney is irrevocable and is given by way of security to secure the performance of the Individual's obligations under this Agreement and the proprietary interest of Tangle Teezer in the Assigned Rights and so long as such obligations of the Individual remain undischarged, or Tangle Teezer has such interest, the power may not be revoked by the Individual, save with the consent of Tangle Teezer.

5.4 Without prejudice to Clause 5.2, Tangle Teezer may, in any way it thinks fit and in the name and on behalf of the Individual:

- (a) take any action that this Agreement requires the Individual to take;

-
- (b) exercise any rights which this Agreement gives to the Individual; and
 - (c) appoint one or more persons to act as substitute attorney(s) for the Individual and to exercise such of the powers conferred by this power of attorney as Tangle Teezer thinks fit and revoke such appointment.

5.5 The Individual undertakes to ratify and confirm everything that Tangle Teezer and any substitute attorney does or arranges or purports to do or arrange in good faith in exercise of any power granted under this clause.

6 WAIVER

No failure or delay by a Party to exercise any right or remedy provided under this Agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

7 ENTIRE AGREEMENT

7.1 This Agreement constitutes the entire agreement between the Parties and supersedes and together extinguish all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

7.2 Each Party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Agreement. Each Party agrees that it shall have no claim for innocent or negligent misrepresentation based on any statement in this Agreement.

8 VARIATION

No variation of this Agreement shall be effective unless it is in writing and signed by the Parties (or their authorised representatives).

9 SEVERANCE

9.1 If any provision or part-provision of this Agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this Clause shall not affect the validity and enforceability of the rest of this Agreement.

9.2 If one Party gives notice to the other of the possibility that any provision or part-provision of this Agreement is invalid, illegal or unenforceable, the Parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

10 COUNTERPARTS

10.1 This Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

10.2 No counterpart shall be effective until each Party has executed and delivered at least one counterpart.

11 THIRD PARTY RIGHTS

This Agreement does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Agreement.

12 NOTICES

12.1 Any notice given to a Party under or in connection with this Agreement shall be in writing and shall be:

- (a) delivered by hand or by pre-paid first-class post or other next working day delivery service at its registered office (if a company) or its principal place of business (in any other case); or
- (b) sent by email to shaun.pulfrey@langiateezer.com

12.2 Any notice shall be deemed to have been received:

- (a) if delivered by hand, on signature of a delivery receipt or at the time the notice is left at the proper address; and
- (b) if sent by pre-paid first-class post or other next working day delivery service, at 9.00 am on the second Business Day after posting or at the time recorded by the delivery service; and
- (c) if sent by email, at the time of transmission, or, if this time falls outside business hours in the place of receipt, when business hours resume. In this Clause, business hours means 9.00am to 5.00pm Monday to Friday on a day that is not a public holiday in the place of receipt.

12.3 This Clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

13 GOVERNING LAW

This Agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.


14 JURISDICTION

Each Party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Agreement or its subject matter or formation.

This Agreement has been executed as a deed and is delivered and takes effect on the date stated at the beginning of it.


