**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), having an effective date of July 9, 2021, is made by Regions Bank, an Alabama banking corporation ("Regions"), in favor of Hibbett Holdings, LLC, an Alabama limited liability company ("Owner").

WHEREAS, Owner owns the trademark registrations set forth in Exhibit A (the "IP Collateral");

WHEREAS, Owner and Regions entered into that certain Intellectual Property Security Agreement dated as of April 16, 2020, recorded at the United States Patent and Trademark Office ("USPTO") on May 5, 2020, at Reel/Frame No. 6930/0607 in the USPTO Trademark Assignment Records database (the "IP Security Agreement"), pursuant to which Owner granted to Regions a security interest in the IP Collateral; and


WHEREAS, Regions now desires to release its security interests in the IP Collateral and terminate the IP Security Agreement.

NOW THEREFORE, Regions (on behalf of itself, its successors and assigns) hereby fully and irrevocably **RELEASES** and terminates, without representation, recourse or warranty whatsoever, the IP Security Agreement and all of its security interests in the IP Collateral, including without limitation the security interests granted under the IP Security Agreement and any other agreement or document delivered in connection with the foregoing, and Regions hereby reassigns any and all such right, title and interest (if any) that Regions or any of its successors and assigns may have in the IP Collateral to the Owner or to the owner that is the record owner of the IP Collateral, as applicable.
