## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made and effective as of June 30, 2021 and is granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (the "Bank") in favor of BROWNELLS, INCORPORATED, an Iowa corporation, also known as Brownells, Inc. or Brownell's, Inc. (the "Debtor").

WHEREAS, Debtor and the Bank entered into that certain Trademark Security Agreement dated June 15, 2020 (the "Trademark Security Agreement") pursuant to which Debtor assigned and granted to the Bank a Security Interest in Debtor's rights, title and interest in and to Debtor's trademark rights as described in further detail in the Trademark Security Agreement including, but not limited to, the trademark registrations and applications identified in the attached Schedule 1 (the "Trademark Collateral")

WHEREAS, Debtor and the Bank entered into that certain Copyright Security Agreement dated June 15, 2020 (the "Copyright Security Agreement") pursuant to which Debtor assigned and granted to the Bank a Security Interest in Debtor's rights, title and interest in and to Debtor's copyrights as described in further detail in the Copyright Security Agreement including, but not limited to, the registrations identified in the attached Schedule 2 (the "Copyright Collateral")

WHEREAS, Debtor and the Bank entered into that certain Patent Security Agreement dated June 15, 2020 (the "Patent Security Agreement") pursuant to which Debtor assigned and granted to the Bank a Security Interest in Debtor's rights, title and interest in and to Debtor's patent rights as described in further detail in the Patent Security Agreement including, but not limited to, those issued patents and pending applications identified in the attached Schedule 3 (the "Patent Collateral");

WHEREAS, Debtor and the Bank entered into that certain Sixth Amended and Restated Revolving Line of Credit Note dated June 15, 2020, executed by the Debtor (if applicable, as amended, restated, supplemented, or modified from time to time); and

WHEREAS, the Bank has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademark Collateral, Copyright Collateral, and Patent Collateral as herein provided.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby states as follows:

The Bank hereby releases and terminates its liens and security interests in the Trademark Collateral, the Copyright Collateral and the Patent Collateral. Without any recourse, representation or warranty, the Bank hereby reassigns to the Debtor any and all right, title and interest that the Bank may have in and to the Trademark Collateral, the Copyright Collateral, and the Patent Collateral. The Bank authorizes the recording officer in the United States Patent and Trademark Office and the Copyright Office to cancel these security interests of record.



