CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Confirmatory Grant"), is entered into as of July 14, 2021, by and between GOBRANDS, INC., a Delaware corporation (the "Company"), BEVERAGES & MORE, INC., a Delaware corporation ("BevMo"), BLUE ROSE SPIRITS, LLC, a Kentucky limited liability company ("Blue Rose"), GB ADVANCED TECHNOLOGIES, LLC, a Delaware limited liability company ("GB Advanced", together with the Company, BevMo and Blue Rose, each a "Grantor", and collectively, the "Grantors"), and JPMORGAN CHASE BANK, N.A. (the "Administrative Agent"), acting in its capacity as administrative agent pursuant to that certain Credit Agreement dated as of July 14, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among Grantors, the other Loan Parties, the Administrative Agent, and the financial institutions signatory thereto.

RECITALS:

- A The Grantors, certain of the Grantors' subsidiaries from time to time party thereto, and the Administrative Agent on behalf of the Secured Parties have entered into that certain Pledge and Security Agreement dated as of July 14, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"; all terms defined in the Security Agreement, wherever used herein, shall have the same meanings herein as are prescribed by the Security Agreement).
- B Pursuant to the terms of the Security Agreement, the Grantors have granted to the Administrative Agent on behalf of the Secured Parties a Lien on and security interest in all of the Grantors' right, title, and interest in, to and under all now owned and hereafter acquired Trademarks, and all products and proceeds thereof, to secure the payment of the Obligations.
- NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby grant to the Administrative Agent, on behalf of the Secured Parties, a continuing Lien on and security interest in all of the Grantors' right, title, and interest in, to, and under the following, in each case to the extent constituting Collateral (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or hereafter created, acquired or arising:
- (a) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, including, without limitation, each United States trademark and trademark application referred to in Schedule 1 attached hereto;
 - (b) all licenses of the foregoing, whether as licensee or licensor;
 - (c) all renewals of the foregoing;
- (d) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof:
- (e) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and
 - (f) all rights corresponding to any of the foregoing throughout the world.

The Lien and security interest contained in this Confirmatory Grant is granted in conjunction with the security interest granted to the Administrative Agent on behalf of the Secured Parties pursuant to the Security Agreement.

This Confirmatory Grant shall be governed by, and construed in accordance with, the internal laws of the State of New York, but giving effect to federal laws applicable to national banks.

This Confirmatory Grant may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Confirmatory Grant by signing any such counterpart. Delivery of an executed counterpart of a signature page of this Confirmatory Grant by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart of this Confirmatory Grant.
