This ABL Termination and Release of Security Interest in Trademarks ("<u>ABL Trademark Release</u>") is made as of July 23, 2021, by DEUTSCHE BANK AG NEW YORK BRANCH (the "<u>Collateral Agent</u>") in favor of in favor of the parties set forth on <u>Schedule I</u> hereto (the "<u>Grantors</u>").

### WITNESSETH:

WHEREAS, Grantors entered into a certain intellectual property security agreement dated February 28, 2017 (the "<u>ABL Intellectual Property Security</u> <u>Agreement</u>") with the Collateral Agent, notice of which was recorded on March 15, 2017 at the United States Patent and Trademark Office at Reel 6008, Frame 0578.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the ABL Intellectual Property Security Agreement or the Security Agreement referred to therein, as the context may require.

WHEREAS, Grantors granted the Collateral Agent, for the ratable benefit of the Secured Parties, under the terms of the ABL Intellectual Property Security Agreement, a security interest (the "Security Interest") in and to certain intellectual property of the Grantors, including all of the Grantors' right, title and interest in and to all trademarks, service marks, domain names, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers, whether registered or unregistered, including the Trademarks listed in Schedule II hereto, together, in each case, with the goodwill of the business connected with the use thereof and symbolized thereby, all registrations and applications for registration for any of the foregoing, all agreements, permits, consents, orders and franchises relating to the license, development, use or disclosure of any of the foregoing to which such Grantor is a party or a beneficiary, any and all claims for damages, other payments and/or injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages, payments or other relief, and any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and/or payable with respect to, and supporting obligations relating to, any and all of the foregoing, and, to the extent not otherwise included, all payments under insurance (whether or not the Collateral Agent is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing (collectively, the "Trademark Collateral").

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Lenders referred to under the ABL Intellectual Property Security Agreement, without representation or

warranty of any kind, hereby releases, terminates, discharges and cancels its Security Interest and Lien in and to the Trademark Collateral arising under the Security Agreement and the ABL Intellectual Property Security Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement or ABL Intellectual Property Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

This ABL Trademark Release shall be governed by, and construed in accordance with, the laws of the State of New York
