I have first-hand knowledge of the facts set forth herein.


The current owner of U.S. trademark registration numbers 4604895 (COOP HOME GOODS) and 4458804 (A-THREAD) is A-Thread Apparel, LLC.

The trademark assignment recorded at Reel/Fame 5745/0925 was recorded in error for the reasons set forth below.

A-Thread Apparel, LLC is the last correct owner of the instant registrations and continues to be the owner of the instant registrations.

On July 1, 2015, an assignment was signed purporting to transfer the instant trademark registrations. This assignment was signed and recorded in error. A-Thread Apparel, LLC was and has always been the owner of the instant registrations. A-Thread Apparel, LLC has continued to oversee the quality of the goods and services marketed under the respective marks, even after July, 2015. The parties to the assignment were given incorrect information as to the assignment and the nature of the assignment, and did not intend to transfer ownership of the instant registrations.
