RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of July 22, 2021, is made by Kayne Senior Credit III Loanco, LLC, in its capacity as Administrative Agent for certain lenders ("Agent"), and is as follows:

WHEREAS, Agent, Epoxy Technology Inc., a Massachusetts corporation ("Epoxy, Inc.") and W.F. Taylor LLC, a Delaware limited liability company ("W.F. Taylor"), are parties to that certain Assignment for Security Trademarks, dated as of September 25, 2018 (the "Epoxy/W.F. Trademark Assignment"), which was recorded with The United States Patent and Trademark Office on September 25, 2018, in its records at Reel 6466, Frame 0150.

WHEREAS, Agent and Epoxies, LLC ("Epoxies, LLC") are parties to that certain Assignment for Security Trademarks, dated as of August 20, 2019 (the "Epoxy Trademark Assignment"), which was recorded with The United States Patent and Trademark Office on August 20, 2019, in its records at Reel 6724, Frame 0844.

WHEREAS, Agent and Adhesives Technology Corporation, a Florida corporation ("Adhesives" and together with Epoxy, Inc., Epoxies, LLC, and W.F. Taylor, the "Debtors"), are parties to that certain Assignment for Security Trademarks, dated as of February 1, 2021 (the "Adhesives Trademark Assignment" and together with the Epoxy/W.F. Trademark Assignment and Epoxy Trademark Assignment, the "Trademark Assignments"), which was recorded with The United States Patent and Trademark Office on February 23, 2021, in its records at Reel 7225, Frame 0779. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Trademark Assignments.

WHEREAS, each Debtor has entered into a Security Agreement, dated September 25, 2018 (the "Security Agreement") in favor of Agent.

WHEREAS, the Trademark Assignments granted to Agent, for the benefit of the lenders, a continuing security interest in and to all of Debtor's right, title and interest in and to the trademarks and service marks listed on Schedule I attached hereto and made a part hereof (, collectively, the "Trademarks"), together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present, and futures violations thereof (collectively, the "Trademark Rights"); and

WHEREAS, Agent desires to release its rights and security interests in the Trademarks, including each mark, registration, and application listed on Schedule I attached hereto, and each of the other Trademark Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally (a), discharges, cancels, releases

and terminates its security interest in, Liens on, and all other rights in, to and under the Trademarks, including each mark, registration, and application listed on Schedule I attached hereto, and the other Trademark Rights, (b) terminates the Trademark Assignments, and (c) re-assigns to the Debtors any and all rights, title and interest it may have in the Trademarks. The Agent agrees to take all further actions, and provide to the Debtors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Debtors, at the Debtors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release
