**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of August 11, 2021 (the “Effective Date”), by Patriarch Partners Agency Services, LLC in its capacity as administrative agent and collateral agent (together with its successors and permitted assigns in such capacity, the “Agent”) in favor of Croscill Home LLC (f/k/a Croscill Acquisition, LLC) (the “Grantor”). Terms used but not defined herein shall have the meanings assigned to such terms in the Credit Agreement (as defined below) and the Security Agreement (as defined below), as applicable.

WHEREAS, reference is made to that certain Credit Agreement, dated as of November 7, 2008 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), among the Grantor, the lenders party thereto from time to time and the Agent;

WHEREAS, in connection with the Credit Agreement, the Grantor entered into (i) that certain Security Agreement, dated as of November 7, 2008 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Security Agreement”), made by the grantors party thereto in favor of the Agent, (ii) those certain Intellectual Property Security Agreements, dated August 1, 2010 and April 30, 2011, which were recorded with the United States Patent and Trademark Office (the “USPTO”) at Reel 4264, Frame 0332 and Reel 4533, Frame 0608, respectively (as may be amended, restated, amended and restated, supplemented, or otherwise modified and in effect from time to time, the “Trademark Security Agreements”); and

WHEREAS, the Grantor has requested that the Agent terminate and release its security interest in the Collateral listed on **Schedule I** hereto (the “Released Trademark Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby covenants and agrees as follows:

Without recourse, representation or warranty of any kind or nature, the Agent, on behalf of itself and the Secured Parties, hereby immediately, automatically and irrevocably terminates, releases, and discharges its security interest in and lien on all of the Grantor’s right, title and interest in, to and under the Released Trademark Collateral, granted pursuant to the Trademark Security Agreements, and reassigns to the Grantor, without recourse, all right, title, and interest of the Agent in the Released Trademark Collateral pursuant to the Trademark Security Agreements, and all proceeds thereof, including, without limitation, any and all causes of action which any exist by reason of infringement of the Released Trademark Collateral.

The Agent hereby irrevocably authorizes the recordation of this Release with the USPTO.


