## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Termination and Release") is granted as of January 13, 2021 by WELLS FARGO BANK, NATIONAL ASSOCIATION, successor to Wells Fargo Retail Finance, LLC, as Collateral Agent (the "Collateral Agent") in favor of EXPRESS, LLC, a Delaware limited liability company, EXPRESS HOLDING, LLC, a Delaware limited liability company, EXPRESS GC, LLC, an Ohio limited liability company, EXPRESS FINANCE CORP., a Delaware corporation ("Finance Corp."), and RETAIL FACTORING, LLC (including any successor thereto relevant to the Collateral) (each, a "Grantor" and collectively, the "Grantors").

WHEREAS, the Grantors, other than Finance Corp., executed and delivered an Intellectual Property ABL Security Agreement dated as of July 6, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "ABL IP Security Agreement") granting the Collateral Agent a security interest in and lien on, among other things, certain trademarks and trademark applications;

WHEREAS, the ABL IP Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office ("USPTO") on July 24, 2007, at Reel 3587, Frame 0379;

WHEREAS, the Grantors, other than Retail Factoring, LLC, executed and delivered an Intellectual Property ABL Security Agreement Supplement dated as of July 29, 2011 ("ABL IP Security Agreement Supplement", and together with the ABL IP Security Agreement, collectively the "Grant") granting the Collateral Agent a security interest in and lien on, among other things, certain trademarks and trademark applications;

WHEREAS, the ABL IP Security Agreement Supplement was recorded in the Trademark Division of the USPTO on August 1, 2011, at Reel 4594, Frame 0949;

WHEREAS, the Grantors have requested that the Collateral Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the trademarks and trademark applications as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) releases and discharges its liens and security interests in the Collateral (as defined in the ABL IP Security Agreement) and the Additional Collateral (as defined in the ABL IP Security Agreement Supplement), including, without limitation, the trademarks and trademark applications identified on Schedule 1 hereto, terminates the Grant in all respects, (ii) terminates the Grant in all respects and shall, upon the Grantors' reasonable request and at the Grantors' sole cost and expense, take all actions reasonably necessary to record with the USPTO or otherwise effectuate the purposes of this Termination and Release, and (iii) authorizes the Grantors to record this Termination and Release with the Commissioner for Trademarks and any other applicable government officer.


For the avoidance of doubt, nothing herein shall constitute termination or release by the Collateral Agent of any other security instrument now or hereafter entered into by any Grantor,
