In this Assignment, unless the context otherwise requires, (a) any reference to gender will include both genders and the neutral gender "it", (b) words importing the singular number will include the plural and vice versa, (c) "or" will not be exclusive, (d) "including" will not be limiting whether or not non-limiting language (such as "without limitation") is used with reference thereto and (e) the words "hereof", "herein", "hereto", "hereunder", "hereby" and similar expressions refer to this Assignment as a whole and not to any particular portion of it.

### 1.4 Governing Law

This Bill of Sale will be governed by and construed, interpreted and enforced in accordance with the laws of California and the federal laws of the United States applicable therein (without reference to conflicts of laws principles).

## ARTICLE 2 ASSIGNMENT

## 2.1 Assignment

The Seller hereby sells, assigns, transfers, delivers and conveys unto the Buyer, absolutely, all of the Seller's right, title and interest in the trademarks and trademark applications set forth on Schedule "A" hereto (the "Trademarks"), including (a) all goodwill associated with the Trademarks, (b) all income, royalties and damages due or payable with respect to the Trademarks, (c) the right to file further applications in any jurisdiction with respect to the Trademarks and to receive registrations therefor and (d) the right to sue third parties for all past, present and future infringement of the Trademarks and any income, royalties or damages due or payable with respect to the Trademarks.

## 2.2 Power of Attorney

In the event that the Seller fails or is unable to take any action required pursuant to Section 3.1 hereof, the Seller hereby constitutes and appoints any director or officer of the Buyer as the true and lawful attorney of the Seller, for and in the name or otherwise on behalf of the Seller, with full power of substitution, to do and execute all acts, deeds and assurances to give effect to the conveyance and assurance of the Trademarks unto the Buyer in the manner herein provided in accordance with the intent and meaning of

this Assignment. Said power of attorney coupled with the Buyer's interest will not be revoked by the dissolution of the Seller or otherwise be revocable.

## ARTICLE 3 GENERAL PROVISIONS

#### 3.1 Further Assurances
