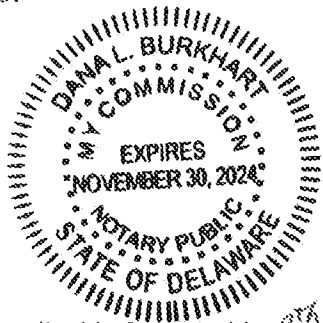
ASSIGNMENT OF TRADEMARKS

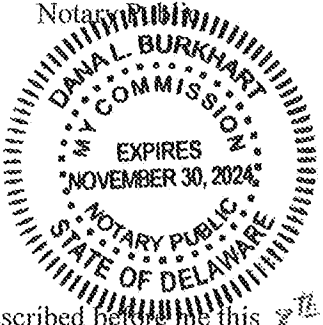
