RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 15, 2021 (the “Effective Date”), is made by BARCLAYS BANK PLC, as Collateral Agent (in such capacity, the “Agent”), in favor of OREGON TOOL, INC. (f/k/a BLOUNT, INC.), a Delaware corporation, SPEECO, INCORPORATED, a Delaware corporation, and WOODS EQUIPMENT COMPANY, a Delaware corporation (each a “Grantor” and collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement by and among the Borrower, the other Grantors party thereto, and the Agent, dated as of April 12, 2016 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of April 12, 2016 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on April 13, 2016 at Reel/Frame 5770/0303 (with respect to Oregon Tool, Inc.), at Reel/Frame 5770/0328 (with respect to with respect to Woods Equipment Company), and at Reel/Frame 5770/0339 (with respect to SpeeCo, Incorporated);

WHEREAS, pursuant to the Security Agreement, and confirmed pursuant to the Trademark Security Agreement, each Grantor granted to the Agent a continuing security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under (i) each United States Trademark constituting Recordable Intellectual Property owned by such Grantor, including, without limitation, each such Trademark registration or application referred to in Schedule 1 hereto, (ii) all rights to sue or otherwise recover for any past, present and future infringement, misappropriation, dilution or other violation of the foregoing, and (iii) all Proceeds of the foregoing, but excluding any Excluded Assets (collectively, the “Trademark Collateral”);


WHEREAS, the Grantors have requested the Agent to release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, hereby (i) terminates the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind. Each Grantor, or any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
