WHEREAS, (a) the 2016 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 8, 2016 at Reel/Frame 5942/0188, (b) the 2017 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 8, 2017 at Reel/Frame 6052/0790, (c) the 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 13, 2018 at Reel/Frame 6499/0557, (d) the 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 23, 2019 at Reel/Frame 6625/0938 and (e) the 2020 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 19, 2020 at Reel/Frame 6895/0501;

If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
- 3. <u>Termination</u>. The Administrative Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

- 4. <u>Further Assurances</u>. The Administrative Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
