RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this “Release”), dated as of October 4, 2021 (the “Effective Date”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, in its capacity as Administrative Agent and Collateral Agent (the “Agent”), in favor of REXNORD INDUSTRIES, LLC, SANITARY-DASH MANUFACTURING CO. and CAMBRIDGE INTERNATIONAL, INC. (the “Grantors”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of July 21, 2006 (as amended and restated by the Amended and Restated Guarantee and Collateral Agreement dated as of October 5, 2009, as further amended and restated by the Second Amended and Restated Guarantee and Collateral Agreement dated as of March 15, 2012, and as further amended, restated, supplemented, or otherwise modified prior to the date hereof, the “Collateral Agreement”), among the Agent, the Grantors and certain other parties thereto, the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, REXNORD INDUSTRIES, LLC executed and delivered that certain Intellectual Property Security Agreement, dated as of July 21, 2006 (which was assigned pursuant to that Notice of Assignment of Patent and Trademark Security Interest, dated as of February 21, 2007), and that certain Supplemental Intellectual Property Security Agreement, dated as of February 23, 2007; and CAMBRIDGE INTERNATIONAL, INC. executed and delivered that certain Patent and Trademark Security Agreement, dated as of November 2, 2016 (collectively with the Intellectual Property Security Agreement, the Notice of Assignment of Patent and Trademark Security Interest and the Supplemental Intellectual Property Security Agreement, the “Patent Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on July 21, 2006 at Reel/Frame 017971/0375;

WHEREAS, the Notice of Assignment of Patent and Trademark Security Interest was recorded with the United States Patent and Trademark Office on March 27, 2007 at Reel/Frame 019063/0875;

WHEREAS, the Supplemental Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on March 26, 2007 at Reel/Frame 019063/0701;

WHEREAS, the Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2016 at Reel/Frame 040556/0001;

WHEREAS, pursuant to the Collateral Agreement, REXNORD INDUSTRIES, LLC executed and delivered that certain Intellectual Property Security Agreement, dated as of July 21, 2006 (which was assigned pursuant to that Notice of Assignment of Patent and Trademark Security Interest, dated as of February 21, 2007); SANITARY-DASH MANUFACTURING CO., INC. executed and delivered that certain Intellectual Property Security Agreement, dated as of February 23, 2007; and CAMBRIDGE INTERNATIONAL, INC. executed and delivered that certain Patent and Trademark Security Agreement, dated as of November 2, 2016 (collectively with the Intellectual Property Security Agreement, dated as of July 21, 2006, the Notice of Assignment of Patent and Trademark Security Interest and the Intellectual Property Security Agreement, dated as of February 23, 2007, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement, dated as of July 21, 2006, was recorded with the United States Patent and Trademark Office on July 21, 2006 at Reel/Frame 3352/0860;

WHEREAS, the Notice of Assignment of Patent and Trademark Security Interest was recorded with the United States Patent and Trademark Office on March 27, 2007 at Reel/Frame 3508/0001;

WHEREAS, the Intellectual Property Security Agreement, dated as of February 23, 2007, was recorded with the United States Patent and Trademark Office on March 26, 2007 at Reel/Frame 3507/0590;

WHEREAS, the Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2016 at Reel/Frame 5913/0595;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement, the Patent Security Agreements or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the patents and patent applications granted as Collateral by the Grantors, including those set forth on Schedule I attached hereto (the “Patent Collateral”) and the trademark registrations and applications granted as Collateral by the Grantors, including those set forth on Schedule II attached hereto (the “Trademark Collateral”), arising under the Collateral Agreement, the Patent Security Agreements and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent Collateral or the Trademark Collateral under the Patent Security Agreements and the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
