## **TRADEMARK ASSIGNMENT AGREEMENT**

Assignee accepts the assignment.

### **2. Representations and Warranties**

Assignor represents and warrants that before making this assignment, he owned all right, title, and interest in and to the Trademarks throughout the world. Both parties also represent and warrant to each other that they have the full power and authority to bind, execute, and deliver this Agreement and to perform all obligations hereunder.

### **3. Recordation**

Either party may record this Agreement with the U.S. Patent and Trademark Office, and with any other trademark office located anywhere in the world, and otherwise confirm the assignment with same.

**4. Additional Documents**

If at any time either party shall deem or be advised that any further writings are necessary or desirable to vest in it the rights provided for herein, the parties agree to do all acts and execute all documents as may reasonably be necessary or proper for that purpose or otherwise to carry out the intent of this Agreement.




