**CERTIFICATE OF AMENDMENT TO
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
INORGANIC INTELLIGENCE, INC.**

Inorganic Intelligence, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “**Company**”), does hereby certify as follows:

1. The name of the Company is Inorganic Intelligence, Inc. The Company’s original Certificate of Incorporation was first filed with the Secretary of State of the State of Delaware on February 18, 2020 under the name Inorganic Intelligence, Inc.

2. The Company’s Amended and Restated Certificate of Incorporation (the “**Restated Certificate**”), is hereby amended by replacing Article FIRST thereof with the following new Article FIRST:

“FIRST: The name of this corporation is Celestial AI Inc. (the “**Company**”).”

3. All other provisions of the Restated Certificate shall remain in full force and effect.

4. This amendment has been duly adopted by the Board of Directors of this Company in accordance with the applicable provisions of Section 242 of the Delaware General Corporation Law, and the stockholders of this Company by written consent in accordance with Section 228 of the Delaware General Corporation Law.
