RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of November 8, 2021 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Agent (the “Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of September 26, 2019, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Patent and Trademark Security Agreement, dated as of September 26, 2019 (the “Patent and Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Copyright Security Agreement, dated as of September 26, 2019 (the “Patent and Trademark Security Agreement”), for recordal with the United States Copyright Office;

WHEREAS, the Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 27, 2019 at Reel/Frame 050592/0105 and Reel/Frame 6757/0312;

WHEREAS, the Copyright Security Agreement was recorded with the United States Copyright Office on September 27, 2019;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, the Patent and Trademark Security Agreement or the Copyright Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Patent and Trademark Collateral, including the patents and patent applications set forth in Schedule I attached hereto and the trademark registrations and applications set forth in Schedule II attached hereto and the Copyright Collateral, including the copyright registrations and applications set forth in Schedule III attached hereto, arising under the Security Agreement, the Patent and Trademark Security Agreement and the Copyright Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent and Trademark Collateral under the Patent or any Copyright Collateral under the Copyright Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels each of the Patent and Trademark Security Agreement and the Copyright Security Agreement.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including,

without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


