#### BILL OF SALE AND INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of October 1, 2021, is made by Wet Seal IP Holdings, LLC ("Seller"), a Delaware limited liability company, in favor of WS IP Acquisitions LLC ("Buyer"), a Delaware limited liability company, the purchaser of certain assets of Seller pursuant to that certain Asset Purchase Agreement by and between Buyer and Seller, dated as of August 20. 2021 (the "Asset Purchase Agreement").

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has conveyed, transferred, and assigned to Buyer, among other assets, certain intellectual property of Seller listed on Schedule I hereto (the "Assigned IP"), and has agreed to execute and deliver this IP Assignment;

NOW THEREFORE, in consideration for the payment of monies specified in the Asset Purchase Agreement, the receipt of which is hereby confirmed, the parties agree as follows:

- Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers, and assigns to Buyer, and Buyer hereby accepts, all of Seller's right, title, and interest in and to the following assets: (a) the Assigned IP, (b) those certain contracts listed on Schedule II hereto, (c) all of Seller's rights under warranties, indemnities and all similar rights against third parties to the extent related to any assets included in this Section 1, (d) all goodwill associated with the trademarks described in Section 1 and the goodwill that may be associated with the other assets described in this Section 1 and (e) all of the Seller's rights and remedies related to any of the foregoing, including the right to sue for and recover damages, profits and any other remedy in connection therewith, for past, present or future infringement, misappropriation or other violation related to any of the foregoing.
- 2. <u>Further Actions</u>. Seller hereby appoints each officer or other authorized representative of Buyer as Seller's true and lawful attorney-in-fact ("Attorney-in-Fact"), with full power of substitution, for Seller and in its name, place and stead and on its behalf and for its use and benefit to execute and deliver all documents and instruments in such form and with such substance and to take all actions on behalf of Seller that such Attorney-in-Fact deems necessary, advisable or appropriate in order to transfer to and vest in Buyer all of the foregoing rights in the Assigned IP and other assets listed in <u>Section 1</u> hereto and to otherwise effectuate the sale and assignment set forth herein, including without limitation any filings with the U.S. Patent and Trademark Office and other trademark offices and Governmental Authorities anywhere in the world that may be necessary to reflect Buyer's title to the Trademarks. Without limiting the foregoing, Buyer may file this IP Assignment in the U.S. Patent and Trademark Office and such other trademark offices and other governmental authorities without any notice to Assignor.
- 3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect to the Assigned IP. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or

inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

- 4. <u>Counterparts</u>. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.
- 5. <u>Successors and Assigns</u>. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 6. Governing Law. This IP Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this IP Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
