**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of November 8, 2021 by **TRUSTMARK GROUP, INC.**, a Delaware corporation (“Lender”) in favor of **WELLTOK, INC.**, a Delaware corporation with an address at 3002 Brighton Boulevard, Unit 743, Denver, Colorado 80216 (the “Grantor”) and its successors, assigns and legal representatives. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Grantor, INCENTONE, INC., WELLTOK MINDBLOOM, INC., PREDILYTICS, INC., SILVERLINK COMMUNICATIONS, LLC, WELLTOK ACQUISITION, LLC, TEA LEAVES HEALTH, LLC, WELLPASS, INC., and VOXIVA, INC.<sup>1</sup> entered into a certain intellectual property security agreement dated December 19, 2019 (the “IP Security Agreement”) with Lender.

WHEREAS, Grantor granted the Lender, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Lender, in and to all of the Intellectual Property Collateral, including without limitation the Copyrights listed in **Schedule A**, the Patents listed in **Schedule B**, the Trademarks listed in **Schedule C**, and the Mask Works listed in **Schedule D**.

WHEREAS, the Lender has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in consideration of the foregoing and intending to be legally bound, the Bank, for itself and on behalf of the lenders in association with the Security Interest, hereby (i) terminates the IP Security Agreement, (ii) releases, terminates and discharges any and all liens, security interests, right, title and interest in, to, and under the Intellectual Property Collateral of the Grantor, and (iii) assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest, together with the goodwill of the business symbolized thereby.
